





**The Traffic and Road Safety (Speed of Motor Vehicle) (Exemption)  
(No. 2) Order, 2010.**

*(Under section 175 of the Traffic and Road Safety Act, Cap. 361).*

IN EXERCISE of the powers conferred upon the Minister responsible for transport by section 175 of the Traffic and Road Safety Act, Cap. 361, this Order is made this 4th day of February, 2010.

**1. Title.**

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 2) Order, 2010.

**2. Exemption.**

A person who drives a motor vehicle and competes in the CBS Premier Sprint organised by the Federation of Motor Sports Clubs of Uganda (FMU) scheduled to take place on 7th February, 2010 at Lubiri Mengo is exempted from the provisions of section 120 of the Traffic and Road Safety Act, Cap. 361.

**3. Maximum speed limit.**

A person who drives a motor vehicle and competes in the CBS Premier Sprint mentioned in paragraph 2, shall not exceed a maximum speed limit of one hundred and sixty kilometers per hour, for the duration of the rally.
