THE PARLIAMENTARY PENSIONS ACT, 2007.

AN Act to make provision for a contributory pension scheme for Members of Parliament and members of staff of Parliament; to establish a Parliamentary Pensions Fund for the payment or granting of pensions or retirement benefits to Members of Parliament and members of staff of Parliament; and to provide for other related matters.

DATE OF ASSENT: 20th July, 2007.

Date of commencement: 1st July, 2001.

BE IT ENACTED by Parliament as follows:

PART I—PRELIMINARY.

1. Commencement.

This Act shall be deemed to have come into force on the 1st day of July, 2001.

2. Interpretation.

In this Act, unless the context otherwise requires—

"Board" means the Board of Trustees established under section 18;

"Fund" means the Parliamentary Pensions Fund established under section 8;

"Member" means a Member of Parliament and a member of staff of Parliament contributing to the Fund;

- "Parliamentary Commission" means the Parliamentary Commission established by and under the Administration of Parliament Act, Cap. 257;
- "pensionable service" means service as a Member beginning from the 2nd day of July, 2001;
- "pensioner" means a person receiving pension under this Act;
- "pensionable emolument" means basic salary, excluding any allowance or gratuity;
- "retirement" means retirement as, or ceasing to be, a Member after a period of five continuous years of service as a Member and on attainment of forty five years of age;
- "Scheme" means the pension scheme established under section 4.

3. Application.

This Act shall apply to any person who, on the date of commencement of this Act, was a Member of Parliament, whether as an elected Member or an *ex-officio* Member, or is a member of staff of Parliament.

PART II—ESTABLISHMENT OF PENSIONS SCHEME AND PENSIONS FUND.

4. Establishment of Scheme.

- (1) There is established a pension scheme, to be known as "the Parliamentary Pension Scheme".
- (2) The Scheme shall be a contributory scheme under which Members of Parliament, members of staff of Parliament and the Government shall make contributions to the Fund in accordance with section 6.

5. Membership of the Scheme.

(1) Membership of the Scheme shall consist of all Members of Parliament, whether elected or *ex-officio*, and members of staff of Parliament except that any Member who is also a Vice President or a Prime Minister shall not be a Member of the Scheme.

- (2) Any Member who is subsequently appointed as Vice President or Prime Minister shall withdraw from the Scheme and shall be entitled to a refund under section 13 (1).
- (3) All Members of the 7th Parliament and staff shall, on the date of commencement of this Act, be deemed to have joined the Scheme.

6. Contributions to the Scheme.

- (1) There shall be a deduction from each monthly payment of the pensionable emolument made to a Member, a sum calculated at the rate of fifteen per cent of the pensionable emolument.
- (2) Government contribution to the Scheme shall be calculated at the rate of thirty percent of the monthly pensionable emolument paid of each Member, or at a rate determined to guarantee the solvency of the Scheme as provided for under section 21.
- (3) Where for any reason the appropriate deduction is not made from a Member's pensionable emolument within any month, there shall be deducted from any other monies payable to a Member, an amount equal to the relevant deduction as if such monies were pensionable emoluments.
- (4) Except as otherwise expressly provided for in this Act, no deduction made under this section or any part of that deduction shall be refunded to a Member.
- (5) The Board shall maintain an individual account for each Member to which all contributions made by each Member under this section shall be credited, and from which there shall be paid all individual benefits under this section in respect of each Member.

7. Deductions not assignable, etc.

Subject to the provisions of this Act, no deductions made under this Act shall be assignable or transferable or liable to be attached, sequestered or levied upon for, or in respect of, any debt or claim.

8. Parliamentary Pensions Fund.

There is established a fund to be known as "the Parliamentary Pensions Fund" for the purposes of the pension scheme referred to in section 4.

9. Objectives of the Fund.

The objectives of the Fund are to—

- (a) collect contributions of Members;
- (b) ensure the grant of reasonable retirement benefits to Members;
- (c) optimise returns of investment on Members' contributions; and
- (d) maintain the long-term solvency and sustainability of the Scheme.

10. Contributions to the Fund.

- (1) Contributions deducted from Members' emoluments and Government contribution under section 6, shall be paid into the Fund.
- (2) Government contribution to the Fund shall be charged on and payable out of the Consolidated Fund without further appropriation other than this section.
- (3) The Government shall, in addition to the contribution made under section 6, contribute the initial liability of the Fund resulting from any pensionable service.

PART III—PENSIONABLE SERVICE AND RETIREMENT BENEFITS.

11. Pensionable service.

(1) Except as otherwise provided under this Act, only continuous service as a Member shall be taken into account as pensionable service.

(2) Any question as to whether a Member's service is or has been continuous or not shall be determined by the Speaker of Parliament.

12. Retirement benefits for former Members.

- (1) Benefits shall be paid to a Member who retires or ceases to be a Member on or after attaining forty five years of age, subject to service as a Member for a continuous period of five years or more.
- (2) The pension payable to a former Member under this section shall be by equal monthly payments.
- (3) Notwithstanding subsection (2) the amount of pension paid to a former Member shall be increased in such percentage to be in line with current rates of emoluments of a Member of Parliament or a member of staff.
- (4) For avoidance of doubt pension shall be calculated basing on the last pensionable emoluments paid to the retired Member.

13. Refund of contributions.

- (1) A Member who retires or ceases to be a Member whose age is less than forty five years, or who has had less than five years of pensionable service, shall be entitled to a refund of the member's contributions together with the contribution made by the Government on his or her behalf calculated with interest.
- (2) For purposes of this Act, a person who ceases to be a Member in consequence of the dissolution of Parliament, or in consequence of a court order relating to any election petition, shall be deemed to continue to be a Member until such time as he or she fails to be re-elected to Parliament.

14. Deferment of payment of benefits.

(1) Notwithstanding the provision of subsection (1) of section 13, a Member whose membership ceases before he or she attains the age of forty five years, but whose pensionable service is five years or more, may leave his or her contribution in the Scheme as deferred

benefits until he or she attains the age of forty five years.

(2) A former Member who opts for deferred benefits under subsection (1) shall, on attaining the age of forty five years, be entitled to his or her benefits including accrued interest.

15. Retirement on health grounds.

Where a Member retires or ceases to be a Member by reason of ill health and the Board is satisfied, on the basis of a report of the Medical Board appointed by the Director General of Medical Services, that there is no reasonable possibility of the Member becoming fit to be an active Member again, the Member shall be paid—

- (a) where the Member has had five or more years of pensionable service, under section 12 notwithstanding that he or she has not attained the age of forty five years; or
- (b) where the Member has less than five years of pensionable service,

a refund of the Member's contributions together with the contribution made by the Government on his or her behalf calculated with interest.

16. Death of Member before retirement.

Where a Member dies when he or she is not eligible for pension under this Act, his or her spouse or children shall be paid—

- (a) a refund of the contributions calculated with interest;
- (b) a gratuity amounting to two years' annual salary based on the last salary earned by the Member before his or her death.

17. Suspension of pension on re-election.

- (1) Where a person receiving pension is re-elected as a Member of Parliament, the payment of the pension or any part thereof shall be supended during the period the Member is in Parliament.
 - (2) For a voidance of doubt, no pension under this Act shall be

paid to a serving Member of Parliament.

PART IV—MANAGEMENT OF THE SCHEME AND FUND

18. Establishment of Board of Trustees.

- (1) There is established a Parliamentary Pension Scheme Board of Trustees consisting of—
 - (a) the Chairperson of the Parliamentary Committee on the Economy, who shall be the Chairperson of the Board;
 - (b) the Minister of Finance;
 - (c) four elected back-bench Commissioners;
 - (d) two members of Parliament elected by members of Parliament;
 - (e) one member of staff elected by the members of staff of Parliament.
- (2) The Clerk to Parliament shall be the Secretary to the Board and Chief Executive of the Fund.
- (3) The Board shall be responsible for the management and control of the Scheme and Fund and shall appoint a professional Fund Manager who will be responsible for investment of the Members' contributions and other monies of the Fund.

19. Expenses of management of Fund.

- (1) The expenses for management and administration of the Scheme and the Fund shall the borne by the Fund.
- (2) The Parliamentary Commission shall be responsible for the set-up costs of managing the Scheme and the Fund.

20. Meetings of the Board.

- (1) The Board shall meet—
- (a) at least once in four months at such time and place as the Chairperson may determine; or
- (b) upon a request in writing to the Chairperson by at least three

- members of the Board.

 (2) The quorum of the Board shall be five members of the Board.
- (3) Subject to the provisions of this Act, the Board may regulate its own procedure at its meetings.
 - (4) The decisions of the Board shall be by simple majority.

PART V—MISCELLANEOUS

21. Government guarantee.

The Government shall, during the short and medium term, guarantee the solvency of the Scheme for any payment that may be required under it.

22. Auditing of accounts.

All accounts of the Scheme shall be audited by the Auditor-General or an Auditor appointed by him or her, at least once in a Financial Year.

23. Actuarial review.

- (1) Once in every five years, or at such other times as the Board may determine, an Actuary appointed by the Board shall review the performance and operations of the Scheme and the Fund and make appropriate recommendations to the Parliamentary Commission.
- (2) A report made under subsection (1) shall be laid before Parliament within two months after it has been made.

24. Regulations.

- (1) The Parliamentary Commission may, by statutory instrument, make regulations for the effective implementation of this Act.
- (2) Any statutory instrument made under this section shall be laid before Parliament and Parliament shall pronounce itself on the statutory instrument by way of a Resolution, within twenty one days

from the date on which it is so laid.

25. Annual report.

The Board shall, within four months after the expiration of each Financial Year, submit to Parliament an Annual Report containing—

- (a) the audited accounts of the Fund;
- (b) the status of the Scheme and a statement of the Investments of the Fund; and
- (c) any other information Parliament may require.

THE MAGISTRATES' COURTS (AMENDMENT) ACT, 2007.

An Act to amend the Magistrates' Courts Act.

DATE OF ASSENT: 20th July, 2007.

Date of commencement: 17th August, 2007.

BE IT ENACTED by Parliament as follows:

1. Abolition of Grade III Magistrate.

The post of Magistrate Grade III is abolished and accordingly, section 4 of the Magistrates' Courts Act, in this Act referred to as the principal Act is amended in subsection (2) by the repeal of paragraph (d).

2. Section 40 of the principal Act amended.

Section 40 of the principal Act is amended by inserting immediately after subsection (1) the following new subsection—

"(1a) In particular, the court shall, when conducting a trial of the offence of defilement, consider the need, in the interest of the child, to exercise its power under article 28(2) of the Constitution, to exclude the press and the public from the proceedings before the court for reasons of morality and to protect the victim of the offence".

3. Amendment of section 75 (2) of principal Act.

Section 75 (2) of the principal Act is amended in subsection (2) as follows—

- (a) by substituting for paragraph (b) the following new paragraph—
 - "(b) the offence of terrorism and any other offence punishable by more than ten years imprisonment under the Anti-Terrorism Act, 2002";
- (b) by substituting for paragraph (d) the following new paragraph—
 - "(d) offences under the Firearms Act punishable by more than ten years imprisonment";
- (c) by repealing paragraph (e);
- (d) by substituting for paragraph (f) the following new paragraph—
 - "(f) rape contrary to section 123 of the Penal Code Act and aggravated defilement under section 129 of that Act".

4. Replacement of section 123 of the principal Act.

For section 123 of the principal Act there is substituted the following new section—

"Trial of accused in his or her absence.

- 123. (1) Except with his or her consent, the trial of any person shall not take place in the absence of that person unless the person so conducts himself or herself as to render the continuance of the proceedings in the presence of that person impracticable and the court makes an order for the person to be removed and the trial to proceed in the absence of that person.
- (2) Where the court decides to try the accused person in his or her absence under subsection (1) of this section, it shall make such provision as in its discretion appears sufficient for informing the accused of what has passed at the trial and for making his or her defence".

5. Amendment of section 161 of the principal Act.

Section 161 of the principal Act is amended by repealing paragraph (d) of subsection (1).

6. Amendment of section 162 of the principal Act.

Section 162 of the principal Act is amended as follows—

- (a) in paragraph (b) of subsection (1), by substituting for the words "one million shillings", the words "four million eight hundred thousand shillings";
- (b) by repealing paragraph (d) of subsection (1);
- (c) by repealing subsections (3) and (4).

7. Amendment of section 164 of the principal Act.

Section 164 of the principal Act is amended by substituting for "Grade I, II or III the words "Grade I or II".

8. Repeal of section 179 of the principal Act.

The principal Act is amended by repealing section 179.

9. Amendment of section 182 of the principal Act.

Section 182 of the principal Act is amended in subsection (4), by the repeal of the words "other than a Magistrate Grade III".

10. Amendment of section 204 of the principal Act.

Section 204 of the principal Act is amended as follows—

- (a) in paragraph (b) of subsection (1), by the repeal of the words "or Grade III";
- (b) in paragraph (b) of subsection (5), by the repeal of the words "or Grade III".

11. Amendment of section 207 of the principal Act.

Section 207 of the principal Act is amended in subsection (1) as follows—

- (a) in paragraph (a), by substituting for "five million shillings" the words "fifty million shillings";
- (b) in paragraph (b) by substituting for "two million shillings" the words "twenty million shillings";
- (c) by repealing paragraph (d).

12. Repeal of Schedule 2 to the principal Act.

Schedule 2 of the principal Act is repealed.

13. Disapplication of Schedules 1 and 3 of the principal Act to Magistrate Grade III.

Schedules 1 and 3 to the principal Act shall cease to apply to Magistrate Grade III and therefore any reference in those Schedules to Magistrate Grade III is repealed.

14. Transitional provisions.

(1) Where, by reason of the amendment made by section 11 of this Act to section 207 of the principal Act, any cases in respect of any causes or matters pending before the High Court at the commencement of this Act,

would have been triable by a court presided over by a Chief Magistrate if commenced after the coming into force of this Act, any such case shall be transferred to the appropriate court presided over by a Chief Magistrate and be heard by that court if the hearing of the case before the High Court has not commenced or if the High Court is satisfied that it is fair for such transfer to be made.

(2) Where, by reason of the amendment made by section 11 of this Act of section 207 of the principal Act, any cases in respect of any causes or matters pending before the High Court or a court presided over by a Chief Magistrate at the commencement of this Act would have been triable by a court presided over by a Magistrate Grade I if commenced after the coming into force of this Act, any such case shall be transferred to the appropriate court presided over by a Magistrate Grade I to be heard by that court if the High Court or the Chief Magistrate has not commenced hearing the case, or if the High Court or the Chief Magistrate as the case may be, is satisfied that it is fair for such a transfer to be made.

THE PENAL CODE (AMENDMENT) ACT, 2007.

An Act to amend the Penal Code Act.

DATE OF ASSENT: 20th July, 2007.

Date of commencement: 17th August, 2007.

BE IT ENACTED by Parliament as follows:

1. Abolition of corporal punishment.

- (1) Corporal punishment is abolished and accordingly, all references to corporal punishment in the Penal Code Act in this Act referred to as the principal Act, are repealed.
- (2) Without prejudice to the general effect of subsection (1) of this section, section 125, subsection (2) of section 129 and section 205 of the Penal Code Act, are amended by the repeal of the words "with or without corporal punishment".

2. Section 129 of the Penal Code Act replaced.

The principal Act is amended by substituting for section 129 the following new sections—

"Defilement of persons under eighteen years of age.

- 129. (1) Any person who performs a sexual act with another person who is below the age of eighteen years, commits a felony known as defilement and is on conviction liable to life imprisonment.
- (2) Any person who attempts to perform a sexual act with another person who is below the age of eighteen years commits an offence and is on conviction, liable to imprisonment not exceeding eighteen years.
- (3) Any person who performs a sexual act with another person who is below the age of eighteen years in any of the circumstances specified in subsection (4) commits a felony called aggravated defilement and is, on conviction by the High Court, liable to suffer death.
- (4) The circumstances referred to in subsection (3) are as follows—
 - (a) where the person against whom the offence is committed is below the age of fourteen years;
 - (b) where the offender is infected with the Human Immunodeficiency Virus (HIV);
 - (c) where the offender is a parent or guardian of or a person in authority over, the person against whom the offence is committed;
 - (d) where the victim of the offence is a person with a disability; or
 - (e) where the offender is a serial offender.
- (5) Any person who attempts to perform a sexual act with another person below the age of eighteen years in any of the circumstances specified in subsection (4), commits an offence and is liable on conviction, to imprisonment for life.
- (6) Where a person is charged with the offence under this section that person shall undergo a medical examination as to his or her Human Immuno Deficiency Virus (HIV) Status.

- (7) In this section—
- "disability" means a substantial functional limitation of daily life activities caused by physical, mental or sensory impairment and environment barriers resulting in limited participation;
- "serial offender" means a person who has a previous conviction for the offence of defilement or aggravated defilement;

"sexual act" means—

- (a) penetration of the vagina, mouth or anus, however slight, of any person by a sexual organ;
- (b) the unlawful use of any object or organ by a person on another person's sexual organ;

"sexual organ" means a vagina or a penis.

Child to child sex.

- 129A. (1) Where the offender in the case of any offence under section 129 is a child under the age of twelve years, the matter shall be dealt with as required by Part V of the Children Act.
- (2) Where an offence under section 129 is committed by a male child and a female child upon each other when each is not below the age of twelve years of age, each of the offenders shall be dealt as required by Part X of the Children Act.

Payment of compensation to victims of defilement.

129B. (1) Where a person is convicted of defilement or aggravated defilement under section 129, the court may, in addition to any sentence imposed on the offender, order that the victim of the offence be paid compensation by the offender for any physical, sexual and psychological harm caused to the victim by the offence.

(2) The amount of compensation shall be determined by the court and the court shall take into account the extent of harm suffered by the victim of the offence, the degree of force used by the offender and medical and other expenses incurred by the victim as a result of the offence".

3. Amendment of section 286 of the principal Act.

The principal Act, is amended in section 286 by substituting for subsections (2) and (3) the following—

- "(2) Notwithstanding subsection (1) (b), where at the time of or immediately before or immediately after the time of the robbery, an offender is in possession of a deadly weapon, or causes death or grievous harm to any person, the offender or any other person jointly concerned in committing the robbery shall, on conviction by the High Court, be liable to suffer death.
 - (3) In subsection (2) "deadly weapon" includes—
 - (a) (i) an instrument made or adapted for shooting, stabbing or cutting, and any imitation of such an instrument;
 - (ii) any substance,

which when used for offensive purposes is capable of causing death or grievous harm or is capable of inducing fear in a person that it is likely to cause death or grievous bodily harm; and

(b) any substance intended to render the victim of the offence unconscious."

4. Repeal of section 288.

The principal Act is amended by repealing section 288.

5. Amendment of section 319 of principal Act.

Section 319 of the principal Act is amended by substituting for subsection (3) the following new subsection—

- (3) In subsection (2) "deadly weapon" includes—
 - (a) (i) an instrument made or adapted for shooting, stabbing or cutting, and any imitation of such an instrument;
 - (ii) any substance,

which when used for offensive purposes is capable of causing death or grievous harm or is capable of inducing fear in a person that it is likely to cause death or grievous bodily harm; and

(b) any substance intended to render the victim of the offence unconscious."

6. Transitional provision.

Where at the commencement of this Act any proceedings are pending before the High Court for the prosecution of the offence of defilement under section 129 of the Penal Code Act, any such proceedings shall be transferred to the appropriate court presided over by a Chief Magistrate if the hearing of the case in the trial has not commenced.

This Order may be cited as the Electricity (Licence Exemption) (Isolated Grid Systems) Order, 2007.

2. Interpretation.

In this Order, unless the context otherwise requires—

- "Act" means the Electricity Act, 1999, Cap 145;
- "Authority" means the Electricity Regulatory Authority established by section 4 of the Act;
- "commercial use" means the supply of electricity from one point to another for sale by one person to another person;
- "distribution licence" means a licence issued under section 57 of the Act;
- "generation licence" means a licence issued under section 51 of the Act:
- "isolated grid supply" means an electricity supply system that is used for commercial purposes and is not connected to the main grid;

- "isolated grid system service standards" means the customer service standards prepared by the Authority and applicable to the operation of isolated grids;
- "isolated grid technical standards" means a set of technical standards prepared by the Authority and applicable to an isolated grid system;

"sale licence" means a licence issued under section 59 of the Act.

3. Application.

- (1) This Order applies to the generation, transmission, distribution or sale of electricity on the isolated grid.
- (2) For the avoidance of doubt this Order does not apply to the generation, transmission, distribution or sale of electricity on the main grid.

4. Object of Order.

The object of this Order is to regulate the supply of electricity from isolated grid systems for commercial use.

5. Certificate of exemption.

- (1) A person intending to generate, distribute and sale electricity for rural electrification, where the maximum supply capacity does not exceed two megawatts shall apply to the Authority for a certificate of exemption in the form set out in Schedule 1.
- (2) A certificate of exemption is sufficient evidence of exemption from the requirement of holding any licence otherwise required to be held under the Act.
- (3) The holder of a certificate of exemption shall comply with the terms set out in the certificate.
- (4) A certificate of exemption shall be in the form set out in Schedule 2.

6. Standards.

- (1) Subject to subparagraph (2), a holder of a certificate of exemption shall be exempted from complying with all or any of the service standards applicable to licensees.
- (2) A holder of a certificate of exemption shall comply with the isolated grid technical standards and the isolated grid system service standards, and shall annually update the Authority with the compliance of the standards.

7. Upgrade of supply capacity.

- (1) Where the holder of a certificate of exemption upgrades the generation capacity to a capacity greater than two megawatts, the certificate of exemption shall automatically lapse.
- (2) The holder of a certificate of exemption who reasonably believes that the supply for which he or she holds a certificate is about to be upgraded above two megawatts, shall apply to the Authority for the necessary licence under the Act.
- (3) A licence applied for under subparagraph (2) shall be granted subject to such conditions as the Authority may determine.
- (4) The Authority may permit the holder of a licence issued under subparagraph (3) to operate under the obligations and standards that are applicable to the licensee prior to obtaining the licence for a duration that the Authority may determine; except that the duration shall not exceed three years.

8. Interconnection with main grid.

- (1) Where a holder of a certificate of exemption wishes to connect to the main grid, the holder of the certificate shall be required to satisfy the technical requirements that a grid distribution licence holder satisfies for purposes of safety and network stability.
- (2) A holder of a certificate of exemption shall apply to the Authority for a generation or distribution and sale licence on interconnection with the main grid.

- (3) A certificate of exemption shall automatically lapse on interconnection with the main grid.
- (4) Notwithstanding the requirements of subparagraph (2), a holder of a certificate of exemption may apply to the Authority for exemption from the requirement to acquire any licence, and the Authority shall, where it deems it appropriate, exempt the applicant from the requirement to hold a licence.

9. Price control.

- (1) The Authority shall issue a price schedule for rural electrification systems every three years.
- (2) The price schedule shall contain formulae for the indexing of prices at intervals between reviews.
- (3) A holder of a certificate of exemption shall set tariffs in such a manner that the average prices shall be consistent with the prices published in the price schedule.
- (4) A holder of a certificate of exemption shall apply to the Authority for an exemption from the application of the price schedule, and the Authority shall, where it deems it appropriate, exempt the applicant from the application of the price schedule.

10. Reporting.

A holder of a certificate of exemption shall, on an annual basis, submit to the Authority information provided for in Schedule 3.

11. Customer service agreement.

- (1) A holder of a certificate of exemption shall prepare a model customer service agreement which shall contain a clause on dispute settlement between the holder of a certificate of exemption and its customers.
- (2) The model agreement shall be submitted to the Authority for approval.
