**The Traffic and Road Safety (Speed of Motor Vehicle)
(Exemption) (No. 5) Order, 2003.**

*(Under section 136 of the Traffic and Road Safety Act, 1998,
Act No. 15 of 1998).*

IN EXERCISE of the powers conferred upon the Minister responsible for works, housing and communications by section 136 of the Traffic and Road Safety Act, 1998, this Order is made this 24th day of July, 2003.

Act 15 of
1998.

1. This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 5) Order, 2003.

Citation.

2. A person who drives a motor vehicle and who competes in the three days Rally competition organised by the Federation of Motor Sports Club of Uganda (FMU) and Motorsport Africa Club (MOSAC), commencing on 5th September, 2003 and ending on 7th September, 2003 is exempted from the provisions of subsections (1) and (2) of section 121 of the Act, for the duration of that rally.
