WHEREAS a referendum to open up political space to allow those who wish to join different organisations/parties to do so to compete for political power was held on the 28th day of July, 2005 at which the contesting sides were the YES side (those who support the multiparty political system) and NO side (those who support retention of the movement political system).

AND WHEREAS polling for the referendum on change of political systems closed at 5:00 p.m. on the 28th day of July, 2005.

AND WHEREAS the Electoral Commission has ascertained the results of the referendum.

Now therefore notice is hereby given by the Electoral Commission, in accordance with Articles 61(b) and 74(1) of the Constitution and Section 8(2) of the Referendum and Other Provisions Act, 2005, Act No. 1 of 2005 that the results of the Referendum are as follows:
