



PREFACE

Founder Members officially adopted this print of the then National Progressive Movement (NPM) Constitution on the 7th April 2004, after due registration of the Party.

At the 4th meeting held in Kampala on 28th December 2005 members of the National Progressive Movement unanimously agreed and resolved to have the Party name changed to People's Progressive Party (PPP).

This was proceeded by the General Notice No. 12 of 2006 given by the Electoral Commission Chairman Eng. Dr. Badru M. Kiggundu dated 9th January 2006 and published in the Uganda Gazette Vol. XCVIX No. 4 of 13th January 2006 in accordance with Section 11(2) of the Political Parties and Organizations Act No. 18 of 2005, in which the intended change from National Progressive Movement (NPM) to People's Progressive Party (PPP) was published.

Further more in another General Notice No. 190 of 2006 issued by the Electoral Commission Acting Chairperson SR. Margaret Magoba in the Uganda Gazette Vol. XCVIX No.32 of 19th May 2006 in accordance with Section 11(3) of the Political Parties and Organizations Act No. 18 of 2005, the change of Our Party name from National Progressive Movement (NPM) to People's Progressive Party (PPP) was approved.
