

THE LOCAL GOVERNMENTS (RATING) ACT, 2005 NOTICE OF COMPLETION OF DRAFT VALUATION LIST (UNDER SECTIONS 11, 12 AND 14)

IN ACCORDANCE with the provision of the Local Governments (Rating) Act 2005, notice is hereby given to the General Public that:-

- The draft valuation lists for the three Divisions of Katwe/ Butego, Kimaanya/ Kyabakuza, and Nyendo/ Ssenyange have been completed.
- Copies of the draft valuation lists are available for inspection for period of (30) days from the 30th of November, 2007.
- 3. A person(s) may take a copy (ies) and extract(s) from the draft Valuation list upon payment of the relevant fee.
- 4. Any person who is aggrieved by:
  - i. the inclusion of any rateable property in the Draft Valuation list; or
  - ii. by any value ascribed in the draft valuation list to a property; or
  - iii. by any other statement made or omitted to be made in the draft valuation list with respect to any rateable property; or
  - iv. in the case of a building or portion of a building occupied in parts, by the valuation in the draft valuation list of that building or portion of a building as a single rateable property, may, within 30 days of publication of this notice serve notice, of objection upon the Local Government to the draft valuation list in relation to the rateable property.

The objections should be delivered to the office of the Senior Assistant Town Clerk at the Division where that property is located and should be acknowledged.

N.B A person shall not be entitled to be heard by the Valuation Court unless he/she has lodged a notice of objection within the stipulated time.

# The Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Labwor County, Abim District) Instrument, 2007.

(Under Section 19(8)(b) of the Electoral Commission Act, Cap 140).

IN EXERCISE of the powers conferred upon the Minister under section 19(8)(b) of the Electoral Commission Act, Cap 140, this Instrument is made this 20th day of November, 2007.

### 1. Title and Commencement.

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Labwor County, Abim District) Instrument, 2007 and shall be deemed to have come into force on the 20th day of November, 2007.

## 2. Appointment of completion date.

The 26th day of November, 2007, is hereby appointed as the date upon which the Commission shall complete the exercise of updating the Voters' Register for purposes of the by-election in Labor County, Abim District.

## 3. No application after completion date.

For purposes of paragraph 2 of this Instrument, after the appointed date, no application form from Labwor County, Abim District shall be accepted by the Electoral Commission, seeking—

- (a) to register as a voter; or
- (b) to transfer to a new voting location.
