These Guidelines are issued by the Public Procurement and Disposal of Public Assets Authority, in consultation with the Ministry of Local Government.

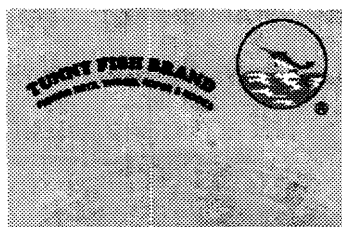

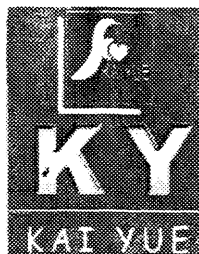
