The Government of Uganda informs all oil companies licensed to deal in petroleum products in Uganda that, in accordance with the Renewable Energy Policy of Uganda, petroleum products can be blended with Biofuels in the ratio of 80% to 20% respectively.

In that regard, dealers in petroleum products are obligated to blend their products up to the prescribed ratio. The Uganda National Bureau of Standards will develop appropriate standards to be followed by biofuel producers.
