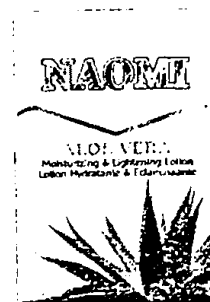

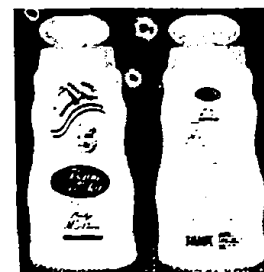

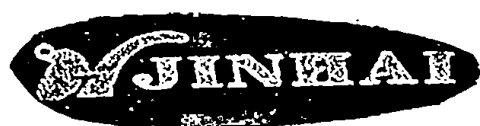

IN EXERCISE of the powers conferred upon the Minister by section 41(1) and (5) of the Uganda Road Fund Act, 2008, this Order is made this 15th day of April, 2009.

**1. Title.**

This Order may be cited as the Uganda Road Fund (Designation of Agencies) Order, 2009.

**2. Commencement.**

This Order shall be deemed to have come into force on the 1st day of July, 2009.
