### **GUIDELINES ON RADIO SPECTRUM HOARDING**

*(In relation to the planning, monitoring, allocation and the use of radio frequency spectrum pursuant to S.27(1) of the Uganda Communications Act, Cap 106)*

Radio spectrum is a finite public natural resource which must be properly managed and used efficiently in the public interest. Where there is a high demand for radio spectrum, the government regulatory institution should take deliberate measures to ensure that this resource is used within certain defined licence conditions and time frames for the provision of communication services to the public.

In certain situations, the licensed operators may deliberately delay to put to use the radio spectrum in order to monopolise the telecommunications market and deny entry to new competitors. Such operator's behaviour translates into radio spectrum hoarding.

In line with its mandate as regulator of the communication sector, a bid to discourage radio spectrum hoarding, and ensure use as stipulated in their licence and frequency licensing conditions. The Uganda Communications Commission has put in place the following Guidelines on Radio Spectrum Hoarding that shall be applicable to both new entrants and the existing operators/users in the telecommunications market in Uganda.

#### **New Operators in the Telecommunications Market**

New operators in the telecommunications market are given a time frame of two hundred and forty (240) days from the time of submitting the application for a Public Infrastructure Licence (PIP Licence) to finalisation of the application requirements ( this includes application review and processing, signing of the licence, submission of frequency network plans, securing Letter of Credit and payment of frequency fees) and additional One hundred and eighty (180) days within which to complete installation of the infrastructure/utilisation of the assigned frequencies and operationalise the Licence.

The following Spectrum hoarding Guidelines are geared towards discouraging Radio Spectrum Hoarding for New Operators/entrants:

- (a) The Licensee shall be required to pay a penalty of 1% of the advised frequency fees/bill for every month for a period of three months during which they are not utilising the frequency. If the frequency

fees plus the penalty fee are not paid after this period, frequency reservation shall automatically revert to the Commission. By cancelling the reservation, the Commission provides an opportunity to other operators/applicants to access that radio spectrum.

- (b) If the PIP Licensee does not finalise installation of the infrastructure/frequency utilisation, the conditions provided under Section 5 (ii) b shall automatically apply.
- (c) Since the PIP Licence will still be valid, the Licensee can use any other resources such as optic fibre to install the infrastructure. The Licensee will only access the withdrawn radio spectrum through fresh application where the Licensee will compete along with other applicants. Policy Guideline No. 4 as in The Uganda Gazette of 20th February 2009 in Vol. CII No. 8 in General Notice No. 51 of 2009 provides that accessing radio spectrum by the applicants is based on First-Come First-serve principle.
- (d) Re-Allocation of radio spectrum that will have reverted to the Commission either through cancellation of radio spectrum reservation and/or through cancellation of frequency assignments shall follow market based approaches. This will be inline with the Commission's radio Spectrum Policy Guideline No. 4 contained in Vol. CII No. 8 in General Notice No. 51 of 2009.

#### **Existing Operators /Users of the Radio Spectrum**

All frequencies assigned to operators/users shall be brought into operation within the stipulated time and shall be paid for annually. The authorisations shall be valid for a period of five years and reviewed thereafter to establish how effectively the radio spectrum is used by the Licensee.

In a situation where the existing operators/users request for additional radio spectrum, the Commission shall, among other conditions for use of that spectrum and based on the nature of service and rollout of the network, stipulate the timeframe within which that resource shall be utilised.

In case the Commission is not satisfied with the level of the utilisation of the assigned radio spectrum or the operator/user does not bring the service within the allowed time frame, the Commission reserves the right to withdraw that radio spectrum. In such a case, the Commission shall give a notice of intention to withdraw the assigned radio spectrum to the concerned operator within a period of 30 days, after which the radio spectrum shall be withdrawn and reverted to the Commission for use by other operators.

### **GUIDELINES FOR TRANSFER AND/OR CHANGE OF CONTROL OF LICENCE**

*(Pursuant to S. 37 of the Uganda Communications Act, Cap 106)*

#### **Mandate**

In fulfilling its mandate to foster the orderly development of communications in Uganda and in order to bring into effect the provisions of S. 37 and S. 57.2 (C) which prohibits anti competitive changes in the market structure and in particular anti competitive mergers and acquisitions in the communications sector, the Uganda Communications Commission hereby issues guidelines for the Transfer of Licences issued under the Act.

#### **Application**

These Guidelines shall apply to all Licences issued by the Uganda Communications Commission in relation to Communications services.

Under Section 37 of the Uganda Communications Act provides that;

- (i) *A Licence shall not be transferred without the written consent of the Commission.*
- (ii) *An Operator may apply to the Commission in a prescribed form and manner for the transfer of a Licence.*
- (iii) *The application under subsection (ii) shall be accompanied by an application, by the person to whom the operator intends to transfer the Licence.*
- (iv) *The Commission shall in considering an application for the transfer of the Licence have regard to the same terms and conditions as in considering a grant of a new Licence, but the Commission may in its absolute discretion refuse to grant the application under this section.*

*The transferee will only receive a Licence term equal to that remaining on the original Licence but will be eligible for the same Licence renewal provisions granted to the original Licence.*

- (v) For purposes of this section—

*“transfer of licence - includes the acquisition of control of the licence holder.”*

*“control - as used with respect to any person shall mean the possession, directly or indirectly, of the power to direct or cause the direction of the management of that person, whether through*

- *the ownership of shares,*
- *voting,*
- *securities,*
- *partnership or other ownership interests,*
- *agreement or otherwise.”*

#### **4. Licence Transfer Guidelines**

In considering a request for transfer and/or change in control of the Licensee, the following Guidelines shall apply;

1. Any assignment or transfer or any change in control, without the Commission's prior written consent shall be considered as a breach of the licence.
2. The Commission will examine each request in accordance with all relevant rules and procedures within a period of not more than 60 working days.
3. In examination of the request, the Commission may conduct a due diligence to determine whether the transferee meets the respective eligibility requirements which shall include but are not limited to the following;

- (i) Evidence of capacity of the transferee to operate the business of the licensee. (Technical and financial Capacity).
- (ii) Experience of the transferee in the business of the licensee. In this regard, the transferee shall be required to provide evidence on the competence of its personnel in the provision of the services stipulated in the licence.
- (iii) In case the transferee has been operating, a letter of good standing from the relevant regulatory authority where the transferee is domiciled.
- (iv) Profile of the transferee and particulars of all its Directors.
- (v) A detailed Sales Purchase Agreement

All the above documents should be authenticated by a Notary Public.

4. The Commission shall in considering an application for transfer/change in shareholding of the Licensee assess the impact of the acquisition/merger/transfer on the level of competition in the relevant markets with particular regard to the following factors;

- (i) barriers to entry into the market,
- (ii) level of concentration,
- (iii) impact on overall market growth, innovation and product differentiation,
- (iv) countervailing power in the market,
- (v) economies of scale,
- (vi) substitutability, and
- (vii) the level of vertical integration in the market.

5. The Commission shall grant approval only if it is certain that the proposed new owner shall demonstrate its ability to comply with all Terms and Conditions of the Licence throughout the remainder of the Licence Period.

6. Prior to transferring the Licence, the Commission reserves the right to request additional documentation to determine if the transferee complies with the appropriate eligibility requirements.
7. An application for transfer of licence shall only be considered by the Commission if the licence is operational. In the case of a Public Infrastructure Provider Licence, operational as used in these Guidelines shall mean that the Licensee has installed infrastructure which is ready for service provision. For a Public Service Provider Licence the licence shall be considered to be operational if there is evidence of services being provided to consumers on commercial basis. Provision of services on a trial basis or for test purposes shall not be construed as having operationalised the licence.
8. In evaluating the request for assignment, transfer, sale or change in control, the Commission may in its sole discretion and among other things, undertake a technical inspection and audit of the telecommunications, radio or postal system to determine whether the system complies with all applicable technical and safety standards and with other Licence Terms and Conditions.
9. In the event of any transfer of a licence, the transferee shall assume all obligations and liabilities of the Licence being transferred and must comply on an ongoing basis with the provisions of the Uganda Communications Act, the Regulations made there under, Policies and all other Laws of Uganda, unless specifically exempted by the Commission at the time the assignment or change in control is approved.
10. The transferee shall pay to the Commission reasonable processing and review expenses in connection with a transfer of the licence or a change in control of the Licence, including without limitation costs of administrative review, financial, legal and technical evaluation of the proposed transferee, notice and publication costs and document preparation expenses. The transferee shall pay an amount of US \$ 10,000 for the said process before the said transfer can be processed.
11. The transferee will only receive a Licence term equal to that remaining on the original Licence but will be eligible for the same Licence renewal provisions granted to the original Licence.

#### 5. Implementation

These Licence Transfer Guidelines shall become effective on 1st January 2010.




