

**The Traffic and Road Safety (Speed of Motor Vehicle) (Exemption)
(No. 10) Order, 2010.**

(Under sections 135 and 175 of the Traffic and Road Safety Act, Cap. 361).

IN EXERCISE of the powers conferred upon the Minister responsible for transport by sections 135 and 175 of the Traffic and Road Safety Act, Cap. 361, this Order is made this 30th day of September, 2010.

1. Title.

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 10) Order, 2010.

2. Exemption.

(1) A person who drives a motor vehicle and who competes in the Ultimate Challenge Motor Cross and Sprint organised by the Federation of Motor Sports Club of Uganda (FMU) in conjunction with Uganda Motor Cross Club, scheduled to take place on the 31st October, 2010 in Busiika, Gayaza-Wakiso District is exempted from the provisions of section 120 of the Traffic and Road Safety Act, Cap. 361, for the duration of the sprint.

(2) A person exempted under sub paragraph (1) shall not exceed a maximum speed of 160 km per hour.
