- New words, "Our society in accordance with the National Constitution", added.

- Objectives (w) & (x) become **Article 8 (17)** and, merged to read "fight ignorance and illiteracy through formal education to all with emphasis on advancing child education, and develop policies that promote practical skills and oriented education. Science and Technology through setting up appropriate institutions with the necessary infrastructure and equipment to offer quality and relevant education at all levels".

- A new objective (19) inserted.

- Clause (i) amended by removing "National Executive Committee" and replacing it with "National Council".
- Clause (iii) amended by adding the words "to be approved by the National Council".




