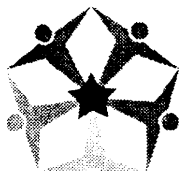



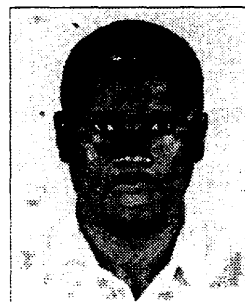

These Regulations may be cited as the Universities and Other Tertiary Institutions Act (Funds of the National Council for Higher Education) Regulations, 2010.

2. Interpretation.

In these Regulations, unless the context otherwise requires—

“Act” means the Universities and Other Tertiary Institutions Act, 2001;

“institution” means a university, other tertiary or degree awarding centre for higher learning be it private or public;

“National Council” means the National Council for Higher Education established by section 4 of the Act;

“other degree awarding institution” means such institution as defined in section 2 of the (Amendment) Act, 2006;

“tertiary institution” means a public or private tertiary institution as defined by section 2 of the Act;

“student” means a person enrolled or intending to be enrolled and registered for the purpose of obtaining an academic qualification at a public or private university, other degree awarding institution or tertiary institution;

“university” means a public or private institution as defined by section 2 of the Act.

3. Funds of the National Council.

(1) Funds of the National Council shall include a contribution from each student of one currency point per year which shall be a pre-condition for student registration and enrolment.

(2) The National Council shall hold bank accounts into which students shall pay their annual contribution of one currency point plus bank charges.

4. Offences and penalties.

(1) Institutions shall not register any student who has not cleared his or her annual contribution to the National Council.

(2) An institution which contravenes these Regulations commits an offence and is liable on conviction to a fine not exceeding one hundred currency points.

(3) A currency point is equivalent to twenty thousand Uganda shillings.
