NOTICE IS HEREBY GIVEN by the Electoral Commission in  
accordance with Section 11(2) of the Political Parties and  
Organisations Act, No. 18 of 2005 that Forum for  
Democratic Change intends to alter/change its Constitution  
as in the Schedule to the Notice.

#### FORUM FOR DEMOCRATIC CHANGE AMMENDMENTS TO THE CONSTITUTION.

### CHAPTER ONE

Insert the acronym "FDC" immediately after the word  
"Change" appearing therein.

### CHAPTER TWO

Ammend article 3 by inserting the words "and a blue key"  
after the word "sign" and deleting the words "and a key"  
appearing therein.

### CHAPTER THREE

(i) Delete article 4 and replace with the following:

#### GOAL, AIMS AND OBJECTIVES.

##### GOAL

5. The goal of the Party shall be;

**The establishment of a truly united and peaceful  
Uganda; and the empowerment of the people of Uganda  
to achieve a better quality of life for all Ugandans.**

(ii) (a) Ammend article 5 (ii) by inserting a new clause to  
read "Service to the Country and the Party."

(b) Add the words "good governance" in (ii).

(c) Add the words "women" and "the aged" after the  
words "workers" and "other" after the word "all."

(iii) In Article 6,

(a) Replace (i) with the following;

**i. Unite and facilitate reconciliation between  
and among the people of Uganda.**

(b) Delete the words "fight for social justice" and "by  
few individuals" appearing in (ii).

(c) Insert a new clause to read;

**(d) Achieve sustainable peace, development, a  
culture of dialogue, compromise, tolerance and  
good governance.**

(e) Delete the word "deprivation" appearing in (iii).

(f) Delete all words after neighbours in (iv) and insert  
a new clause to read "Promote sub-regional and  
regional integration efforts."

(g) Insert a new clause to read;

**Act as a platform to promote democracy, good  
governance, constitutionalism and rule of law.**

(h) Insert a new clause to read "support cultural and  
traditional institutions."

(i) Delete the words "thereby guarantee" in (ix).

(j) Add the words "through the implementation of  
affirmative action" after the word "groups" in  
(xiv).

(k) Delete (xvi).

(iv) Add a new clause with the title "Affirmative Action"  
reading;

### AFFIRMATIVE ACTION

8. (i) **In order to ensure that women are adequately  
represented in all party structures, the party  
shall implement a program of affirmative  
action for women of at least 40% in all its  
structures.**

(ii) **The method of achieving such implementation  
shall be detailed in all party guidelines, party  
platform and manifesto.**

**A member can apply for life membership according to regulations made by the National Council which may also bestow life membership upon persons who have made outstanding contribution in the development of the party.**
  - (e) Replace (iv) with;
    - v. The National Council may on its own or on recommendation of any organ of the Party grant honorary membership to persons who have demonstrated unwavering commitment and support to the party.
- (ii) In article 7,
- (a) Insert the words "In accordance with this Constitution" in the opening line.
  - (b) Add the words "other than an honorary member" after the word "party" therein.
  - (c) Replace the words "by way of voting" with words "in any party activity" in (iii).
  - (d) Add the words "for consideration" at the end of (iv) and word "petition" after the word "question" therein.
  - (e) Add the words "or any of its regulations" at the end of (v).

- (a) Add a new clause to read "canvass support for the party."

## CHAPTER FIVE

Delete the whole of chapter five and replace with the following;

## CHAPTER FIVE

### PARTY STRUCTURES

- 3. The party shall have structures at Polling Area Branch (PAB), parish, sub county, constituency, district, national and Diaspora level for its efficient organization.

### i POLLING AREA BRANCH

- a] Every polling station shall have a Party branch comprising all the members of the party resident in the polling area.
- b] The polling area party branch [hereinafter referred to as the Party branch] shall be the nucleus of the Party and every member desirous of becoming a party member shall do so by registering at polling area Party branch.
- c] For the avoidance of doubt in institutions of learning where there may be no polling station, an organizational unit shall constitute a Party branch and carry out such other functions as any other branch would have carried out.

### ii. COMPOSITION OF THE POLLING AREA BRANCH

- a) Every party Branch shall elect once in every four years, a Party branch committee at elections authorized by the Party's National Council.
- b) The Party Branch Committee shall comprise;
  - 1) The Party Branch Chairperson;
  - 2) The Party Branch Deputy Chairperson who shall be a woman if a man is elected chairperson provided always that nothing shall prohibit election of women to both offices of chair and deputy chairperson;
  - 3) The Branch Treasurer;
  - 4) The Branch General Secretary;
  - 5) Secretary for Information and Publicity;
  - 6) Secretary for Mobilization and Election;
  - 7) Secretary for Health;
  - 8) Secretary for Education;
  - 9) Secretary for Environment;
  - 10) Secretary for Security;
  - 11) Secretary for Elders, Veterans and Pensioners;
  - 12) Secretary for Youths and Sports;
  - 13) Secretary for Women;
  - 14) Secretary for Persons with Disabilities;
  - 15) Secretary for Research;
  - 16) Secretary for Development;
  - 17) Three other members two of whom shall be women.

### iii. FUNCTIONS OF THE POLLING AREA BRANCH COMMITTEE

The Party Branch Committee shall be responsible for the general mobilization and recruitment of members at the polling branch level.

### 14. THE PARISH CONFERENCE

The party shall have a parish conference whose membership shall consist of all polling Area Branch Executive Committee members and the Executive Committee of the parish.

**i. FUNCTIONS OF THE PARTY PARISH CONFERENCE**

The party parish conference shall:

- (a) Oversee the implementation of the party's programmes within the parish;
- (b) Conduct elections for positions in the parish committees.

**ii. COMPOSITION OF THE PARISH EXECUTIVE COMMITTEE**

The Parish Party Conference shall elect, at elections authorised by the Party National Council and the Party Parish Committee comprising:

- 1) The Parish Committee Chairperson;
- 2) The Parish Committee Deputy Chairperson who shall be a woman if a man is elected chairperson provided always that nothing shall prohibit election of women to both offices of chair and deputy chairperson;
- 3) The Parish Treasurer;
- 4) The Parish General Secretary;
- 5) Secretary for Mobilization, Information and Publicity;
- 6) Secretary for Elders, Pensioners, and Veterans;
- 7) Secretary for Youths and Sports;
- 8) Secretary for Women;
- 9) Secretary for Social Services;
- 10) Secretary for Persons with Disability.

Three other members two of whom shall be women.

**iii. FUNCTIONS OF THE PARTY PARISH COMMITTEE**

The party parish committee shall:

- i. Be responsible for the general administration of the party operations at the parish level;
- ii. Transmit Party decisions from the sub-county level to the branch;
- iii. Advise on the implementation of party policies at the branches;
- iv. Transmit information from the branches to the sub-county committee and from the sub-county committee to the branches;
- v. Supervise the collection of membership dues from the branches and the banking on the district bank account;
- vi. Supervise elections at the branches in the parish;
- vii. Coordinate the activities of the party in all branches;
- viii. Receive monthly reports of the party's operations from all branches in the parish.

**15. THE SUB-COUNTY CONFERENCE**

The party shall have a Sub-County Party Conference whose membership shall consist of all Parish Party Branch Committee members and the sub-county executive;

**i. FUNCTIONS OF THE PARTY SUB-COUNTY CONFERENCE**

The Party Sub-county Conference shall:

- a) Oversee the implementation of the Party's programmes within the Sub-county;
- b) Coordinate the activities of the party in all the parish branches in the sub-county;
- c) Conduct elections for positions in the Sub-county committees.

**ii. COMPOSITION OF THE SUB-COUNTY EXECUTIVE COMMITTEE**

The Sub-county Party Conference shall elect, at elections authorized by the Party National Council, the Sub-county Committee comprising:

- 1) The Sub-county Committee Chairperson;
- 2) The Sub-county Committee Deputy Chairperson who shall be a woman if a man is elected chairperson provided always that nothing shall prohibit election of women to both offices of chair and deputy chairperson;
- 3) The Sub-county Treasurer;
- 4) The Sub-county General Secretary;
- 5) Secretary for Mobilization, Information and Publicity;
- 6) Secretary for Elders, Pensioners, and Veterans;
- 7) Secretary for Youths and Sports;
- 8) Secretary for Women;
- 9) Secretary for Social Services;
- 10) Secretary for Persons with Disability.

Three other members two of whom shall be women

**iii. FUNCTIONS OF THE SUB-COUNTY EXECUTIVE COMMITTEE**

The Party Sub-county Committee shall:

- a) Be responsible for the general administration of the party operations at the sub-county level;
- b) Receive monthly reports of the party's operations from all parish branches in the sub-county;
- c) Coordinate the activities of the party in all the Parish branches in the sub-county;
- d) Transmit Party decisions from the constituency and district levels to the lower branches;
- e) Advise on the implementation of Party policies at the branches;
- f) Transmit information from the branches to the constituency and district committees and from the constituency and district committees to the branches;
- g) Supervise elections at the Parish branches in the sub-county.

**16. THE PARTY CONSTITUENCY CONFERENCE**

The party shall establish a Constituency Party Conference whose membership shall comprise the following:

- 1) The Constituency Executive;
- 2) The Sub-county Executives;
- 3) Two delegates to the delegates conference

- 4) Constituency Member of Parliament;
- 5) Local Council 5 Chairperson – *ex officio*;
- 6) Woman Member of Parliament – *ex officio*;
- 7) Local Government District Councilors in the constituency.

### **i. FUNCTIONS OF THE CONSTITUENCY CONFERENCE**

The Constituency Conference shall:

- (a) Ensure that there are party candidates in all electoral positions in the constituency;
- (b) Receive reports on the work of the party in the constituency;
- (c) Make recommendations to the district on the work of the party in the constituency.

### **ii. COMPOSITION OF THE CONSTITUENCY EXECUTIVE COMMITTEE**

- (a) The Party Constituency Committee shall comprise:
  - 1) Constituency Committee Chairperson;
  - 2) The Constituency Committee Deputy Chairperson who shall be a woman if a man is elected chairperson provided always that nothing shall prohibit election of women to both offices of chair and deputy chairperson;
  - 3) The Constituency Treasurer;
  - 4) The Constituency General Secretary;
  - 5) Secretary for Mobilization, Information and Publicity;
  - 6) Secretary for Elders, Pensioners, and Veterans;
  - 7) Secretary for Youths and Sports;
  - 8) Secretary for Women;
  - 9) Secretary for Social Services;
  - 10) Secretary for Persons with Disability;
  - 11) Two delegates of the National Delegates Conference, one of whom shall be a woman.

Three other members two of whom shall be women.

### **iii. FUNCTIONS OF THE PARTY CONSTITUENCY COMMITTEE**

The Party Constituency Committee shall:

- i) Oversee the work and implementation of the programs of the party in the constituency;
- ii) Transmit to and receive from Sub-county committees reports of the party's national programs;
- iii) Coordinate the activities of the Sub-counties in the constituency;
- iv) Transmit to the National Secretariat the names of the identified candidates for political office;
- v) Transmit information from the sub-county to the district and the district to the sub-county;
- vi) Supervise the work of the constituency, sub county and branch committees.

## **17. DISTRICT CONFERENCE**

There shall be a District Conference comprising of the following—

- i) Members of the Party Constituency Committees;
- ii) Party members of Parliament from the district;
- iii) Party members elected to the Local Government District Council;
- iv) District Party Executive Committee Members;
- v) Party Sub-county Chairpersons.

### **i. FUNCTIONS OF THE DISTRICT CONFERENCE**

The Party District Conference shall:

- a) Oversee the implementation of the Party's programs within the District;
- b) Coordinate the activities of the party in all the constituency branches in the District;
- c) Ensure that elections are held to fill all positions in the District.

### **ii. COMPOSITION OF THE DISTRICT EXECUTIVE COMMITTEE**

There shall be established a District Executive Committee for each District, which shall comprise of:

- 1) Chairperson;
- 2) Deputy Chairperson who shall be a woman if a man is elected chairperson provided always that nothing shall prohibit the election of women to both offices of chair and deputy chair;
- 3) General Secretary;
- 4) Treasurer;
- 5) Secretary for Information and Publicity;
- 6) Secretary for Mobilization;
- 7) Secretary for Health;
- 8) Secretary for Education;
- 9) Secretary for Environment;
- 10) Secretary for Security;
- 11) Secretary for Elders, Veterans and Pensioners;
- 12) Secretary for Youths and Sports;
- 13) Secretary for Women;
- 14) Youth (male);
- 15) Youth (female);
- 16) One representative of District Worker's Solidarity;
- 17) One representative of District groups of Persons with Disabilities;
- 18) Four other members who shall be women.

### **iii. FUNCTIONS OF THE PARTY DISTRICT COMMITTEE**

The Party District Committee shall:

- a) Review the party's work in the District and make appropriate monthly reports and recommendations to the National Executive Committee;
- b) Monitor and promote national Party activities;
- c) Report any acts of indiscipline by any party member to the National Secretariat for action;

The Chairperson of the committee shall convene meetings of both the conference and the committee.

"District" has the same meaning as district under the Local Government Act provided that in case of Kampala, a division shall have the same meaning and be equivalent to a district under this constitution.

## 18. THE NATIONAL COUNCIL

### i. COMPOSITION OF THE NATIONAL COUNCIL

There shall be a National Council of the Party consisting of:

- a) District Chairpersons of the party;
- b) All Party officials elected by the National Delegates Conference;
- c) Members of Parliament;
- d) Two representatives per league of each league specified in Chapter 6, 23a;
- e) Eminent persons of the party not exceeding ten approved by the National Council on recommendation of the National Executive Committee;
- f) Elected Local Government District Chairpersons and Municipality Mayors.

### ii. FUNCTIONS OF THE NATIONAL COUNCIL

- a) Implement the decisions of the National Delegates Conference.
- b) Oversee the decisions of the National Delegates Conference.
- c) Act for and on behalf of the National Delegates Conference in such matters as the conference may determine.
- d) Receive reports on the work of the Women League, Youth League and Persons with Disability.
- e) Issue policy directives as and when it sees fit.
- f) Receive reports, and delegate such of its functions to the National Executive Committee as it may consider necessary.
- g) Generate the policy for consideration by the National Delegates Conference.
- h) Approve the budget of the Party.
- i) Supervise and direct the work of National Executive Committee and other National party organs.
- j) Ensure that party organs function democratically and effectively.
- k) Make rules and regulations for giving effect to the provisions of this Constitution.

## 19. THE NATIONAL EXECUTIVE COMMITTEE

### i. COMPOSITION

- a) There shall be an Executive Committee comprising of the following:
  - 1) The President.
  - 2) Party Chairman.
  - 3) Four Deputy Presidents.
  - 4) Four Vice Chairmen.

- 5) Secretary General.
- 6) Deputy Secretary General (Policy and Research).
- 7) Deputy Secretary General (Administration)
- 8) Treasurer General.
- 9) Deputy Treasurer General (Budget).
- 10) Deputy Treasurer General (Fundraising).
- 11) Secretary for Organization and Mobilization.
- 12) Secretary for Information and Publicity.
- 13) Secretary for Women Affairs (Chairperson Women League).
- 14) Secretary for Youths Affairs (Chairperson Youth League).
- 15) Secretary for Persons with Disabilities.
- 16) Secretary for International and Regional Affairs.
- 17) Secretary for Legal, Human Rights and Constitutional Affairs.
- 18) Secretary for Environment.
- 19) Secretary for Labour.
- 20) Secretary for Sports and Arts.
- 21) Secretary for Economy and Investments.
- 22) Secretary for Trade and Industry.
- 23) Secretary for Defence and Security.
- 24) Secretary for Culture, Ethics and Religious Affairs.
- 25) Secretary for Internal Affairs.
- 26) Secretary for Agriculture and Rural Development.
- 27) Secretary for Veterans and Pensioners.
- 28) Secretary for Health.
- 29) Secretary for Works, Transport and Communications.
- 30) Secretary for Education.
- 31) Secretary for Local Government.
- 32) Secretary for post Conflict Reconstruction.
- 33) Secretary for the Elders.
- 34) Chief Electoral Commissioner.
- 35) Party Envoys.
- 36) Four Committee members elected by the National Delegates Conference.
- 37) Ten Members of Parliament elected by the Parliamentary Caucus.
- 38) Ten District Local Government Chairpersons elected by District Chairpersons Caucus.
- 39) Standing Committee Members.

### b). DEPUTY SECRETARIES

- (1) There shall be Deputy Secretaries appointed by the President and approved by the National Executive Committee.

- 2) The positions of the Deputy Secretaries shall be proposed by the President and approved by the National Council.
- c) Each secretary shall present a quarterly report to the National Executive Committee.
- d) Members of the National Executive Committee shall be elected by the National Delegates Conference.

**ii. THE FUNCTIONS OF THE NATIONAL EXECUTIVE COMMITTEE ARE:**

- 1) Originate policy for consideration by the National Council.
- 2) Supervise the National Secretariat.
- 3) Implement decisions of the National Conference and National Council.
- 4) Levy such fee on a member holding elective office by reason of the party ticket and refer the matter to the disciplinary committee where there is non compliance.
- 5) Issue and send directives and instructions to and receive reports from the Districts.
- 6) Suspend or dissolve any District committee where necessary and call for a new election where there has been a breach of this constitution or disregard of democratic principles and the district conference has failed to act.
- 7) Manage and control all national and international property and other assets of the party.

**20. THE NATIONAL EXECUTIVE COMMITTEE MAY ESTABLISH SUCH COMMITTEES AS IT MAY DEEM NECESSARY FOR THE EFFICIENT DISCHARGE OF THE PARTY FUNCTIONS**

- 1) The National Executive Committee may through a two thirds majority of all its members make rules and regulations.

**21. THE NATIONAL DELEGATE'S CONFERENCE**

The National Delegates Conference shall be the supreme policy making organ of the party.

**i. Composition of the National Delegates Conference**

The membership of the National Delegates Conference shall consist of the following:

- 1) The Chairperson.
- 2) The Vice Chairpersons.
- 3) All members of National Council.
- 4) All Members of the National Executive Committee.
- 5) Four representatives from each of the special interest groups.
- 6) The Chairperson, General Secretary, Secretary for mobilization, secretary for women and Secretary for Youths from each district.
- 7) All Members of Parliament.
- 8) Two representatives from each parliamentary constituency one of whom shall be female.

- 9) Ten eminent members of the party nominated by the National Executive Committee and approved by the National Council.

- 10) 10 representatives of the Diaspora.

The National Delegates Conference shall meet at least once every three years.

**ii. Functions of the National Delegates Conference shall be:**

- a) Elect the National Executive Committee (NEC);
- b) Determine the programs and policies of the party and take policy positions on any matter;
- c) Receive, discuss and make decisions on reports from any organ of the party;
- d) Consider the annual reports of the National Council;
- e) Set up a National Campaign Task Force in an election year;
- f) To receive reports of the Party President, the Secretary General and the Treasurer General.

**iii. Meetings of the National Delegates Conference**

- a) The National Delegates' Conference shall meet once every three years on such date and at such place as the Chairman may determine provided that a Special Delegates Conference may be convened at any time to consider urgent matters.
- b) An extra ordinary meeting shall be convened by the Chairperson in any of the following circumstances:
  - 1) When the Chairperson so decides,
  - 2) On receipt of a petition from one half of the district executive committees,
  - 3) On receipt of a petition from 30% of the delegates from at least 50% of all districts in the country,
  - 4) Where the National Executive Committee requests.

**CHAPTER SIX**

Delete the whole chapter six on special organs and replace with the following;

**22. SPECIAL ORGANS**

There shall be established Party Leagues, Caucuses and Structures for the Diaspora.

**1. PARTY LEAGUES**

There shall be the following Party Leagues:

**i. YOUTH LEAGUE**

- 1) There shall be a Youth League formed by Youth members of the party.
- 2) The Youth League shall be constituted at the polling area branch, parish, sub-county, constituency, district and national levels.

- 3) The League shall be composed of all youths in the party.
- 4) The league shall have a constitution to manage its affairs approved by the National Executive Committee and in alignment with and subordinate to the Party Constitution.

## ii. WOMEN LEAGUE

- 1) There shall be a Women League formed by all female members of the Party.
- 2) The Women League shall be constituted at the polling area branch, parish, sub-county, constituency, district and national levels.
- 3) The league shall have a constitution to manage its affairs approved by the National Executive Committee and in alignment with and subordinate to the Party Constitution.

## iii. WORKERS' LEAGUE

- 1) There shall be a Workers' League formed by all unionized workers of the party.
- 2) The Workers' League shall be constituted at the District and national levels.
- 3) The league shall have a constitution to manage its affairs approved by the National Executive Committee and in alignment with and subordinate to the Party Constitution.

## IV. THE DIASPORA

There shall be established Diaspora Chapters for the effective organization and management of party activities in the Diaspora:

- 1) The Diaspora shall be organized in Chapters approved by the National Executive Committee.
- 2) The National Executive Committee shall make provisions for the establishment of the leadership of the Chapters taking into consideration the uniqueness of the structures.
- 3) A Chapter will establish its leadership in accordance with this constitution and regulations made by the National Executive Committee.

## 23. CAUCUSES

There is established Caucus of the party at Parliamentary and local government level:

### i. PARLIAMENTARY CAUCUS

- 1) The Parliamentary Caucus shall be composed by all members of parliament of the party.
- 2) The function of the Caucus shall be to advance the interests of the party in the national legislature.
- 3) The Caucus shall elect its executive in accordance with the regulations approved by the National Executive Committee of the party.

## ii. DISTRICT LOCAL GOVERNMENT CAUCUS

- 1) The District Local Government Caucus shall be composed by all members of the party in the District Council.
- 2) The function of the Caucus shall be to advance the interests of the Party in the Council.
- 3) The Caucus shall elect its executive in accordance with the regulations approved by the National Executive Committee of the party.

## iii. SUB-COUNTY LOCAL GOVERNMENT CAUCUS

- 1) The Sub-county Local Government Caucus shall be composed by all members of the party in the Sub-county Council.
- 2) The function of the Caucus shall be to advance the interests of the party in the Council.
- 3) The Caucus shall elect its executive in accordance with the regulations approved by the National Executive Committee of the party.

## iv. THERE IS ESTABLISHED A SPECIAL ORGAN OF THE PARTY TO BE;

- i) Known as Caucus of District Chairpersons comprising of elected chairpersons of all districts and mayors of municipalities.
- ii) The District Chairpersons Caucus shall be represented on National Executive Committee, to which it reports, by ten representatives elected from among themselves.

## 25. PERSONS WITH DISABILITY

There shall be a special organ known as Persons with Disability formed by all persons with disability in the party:

- a) The organ shall be constituted at the District and national levels.
- b) The organ shall have a constitution to manage its affairs approved by the National Executive Committee and in alignment with and subordinate to the Party Constitution.

## CHAPTER SIX

- (i) Rename this as a "CHAPTER SEVEN"

- (ii) Replace the whole of the said chapter, save Article 28 with the following;

## 26. STANDING COMMITTEES

There shall be established the following standing committees:

1. Committee on Discipline.
2. Finance and Welfare Committee.
3. Electoral Committee.
4. Legal, Human Rights and Constitutional Affairs Committee.
5. Publicity Committee.
6. National Election Tribunal.

7. Mobilization and Recruitment Committee.
8. Arbitration Committee.

### **The Committee on Discipline**

There shall be a committee of discipline at National, District, Constituency, Sub-County, parish and polling area branch level.

#### **1. Composition**

- a) The National Committee shall consist of the Chairperson who shall be one of the vice chairpersons of the National Delegates Conference, Organization and Mobilization Secretary, and four committee members elected by the National Delegates Conference on recommendation of the National Executive Committee.
- b) The lower organs of the party shall have disciplinary committees and shall be constituted in the same manner with appropriate modifications.

#### **2. Functions of the committee shall be;**

- a) Exercise disciplinary control over all members of the party.
- b) To enforce the Code of Conduct.
- c) To do such other things as the National Council may from time to time direct.

A CODE OF CONDUCT approved by National Executive Committee shall guide the ethical standards and probity of members.

#### **3. Finance and Welfare Committee**

- i. The Committee on Finance and Welfare shall consist of the Treasurer General, Deputy Treasurer General, Deputy Secretary General (Administration) Organization and Mobilization Secretary, two members of the national executive committee elected annually by the National Council. The Treasurer General shall be Chairperson of the committee.
- ii. The functions of the committee shall be to:
  - a) To raise funds for the Party.
  - b) Supervise the auditing of the party accounts.
  - c) Ensure accountability and sound financial management of party funds.
  - d) Perform any other functions, which the National Executive may assign it.

#### **4. The Legal, Human Rights and Constitutional Affairs Committee**

There is established in the party a Legal, Human Rights and Constitutional Affairs Committee:

- i) The Committee shall comprise of the Secretary for Legal affairs and such number of members as the National Council may determine.
- ii) The members to the Committee shall be appointed by the Party President with the approval of National Council.

#### **iii) The functionS of the Committee shall be:**

- a) To give legal advice to the party organs and officials on any subject.
- b) To represent the Party and its officials in the courts of law.
- c) Draw and peruse agreements which the party wishes to enter into.
- d) Perform any other function as may be assigned.

#### **5. Publicity Committee**

There is established in the Party a Publicity Committee:

- i) The Committee shall comprise the Secretary for Information and Publicity and such other number of members as the National Council may determine.
- ii) The said members shall be appointed by the President with approval of the National Council.
- iii) The functions of the Committee shall be:
  - a) Promote the corporate image of the party.
  - b) Communicate policies, programs and decisions of the party to all branches.
  - c) Provide information to the media.
  - d) Implement the party communication guidelines approved by the National Executive Committee.

#### **6. Security Committee**

There is established in the Party a Security Committee:

- a) The Committee shall comprise the Secretary for Security such other number of members as the National Council may determine.
- b) The said members shall be appointed by the President with approval of the National Council.

The functions of the Committee shall be:

- a) Promote the Security of the party and its members;
- b) Ensure the safety of party property;
- c) Advise all organs of the party on matters relating to security.

#### **7. The National Election Tribunal**

- a) There is established National Election Tribunal whose Chairperson shall be one of the Deputy Presidents and shall comprise the Secretary for Organization and Mobilization, Secretary for Information and Publicity, a representative of the Disciplinary Committee and the Chairman of the Legal Committee, provided that where the holder of any of the said offices is contesting for any elective office, he / she shall be disqualified from taking part in the proceedings.
- b) The function of the Committee shall be to resolve disputes arising out of party elections.
- c) The lower organs of the party shall have elections tribunals at the sub county and district level and shall be constituted in the same manner with appropriate modifications.



**8. The Mobilization and Recruitment Committee**

There is established a Committee for Mobilization and Recruitment in the party.

**Composition**

- 1) The Committee shall comprise 10 members under the Chairmanship of the Organization and Mobilization Secretary.
- 2) The said members shall be appointed by the President with approval of the National Council.

**Functions**

The functions of the Committee shall be:

- a) To recruit and enroll members for the party.
- b) To mobilize party supporters.

**9. Arbitration Committee**

There shall be an Arbitration Committee composed of five members elected by the National Delegates Conference from among the elders of the party to arbitrate any disputes between organs and leadership of the party or its leadership.

The Committee shall have powers to interpret this Constitution and the decision of the Committee shall be final and binding.

Introduce a new chapter to provide for Party offices to read as follows:

**PARTY OFFICES****(i) Party Chairperson**

There shall be a Chairperson and four Vice Chairpersons of the Party.

The Chairperson shall:

- a) Convene and chair the National Delegates Conference, and the National Council;
- b) Oversee discipline and overall ethical standards in the party;
- c) Ensure harmony within the party;
- d) Receive periodical reports from the presidency and government performance when the party is in power;
- e) Mobilize support for the Party internally and internationally.

The Vice Chairpersons shall deputize the Chairperson.

**(ii) Party President**

There shall be a President and four Deputies of the Party.

The President shall:

- a) Preside over the National Executive Committee,
- b) Monitoring and keep under constant review the implementation of all the decisions of the National Executive Committee,
- c) Submit recommendation of decisions ad hoc committees to the National Executive Committee,
- d) Perform any other functions as the National Executive Committee, National Council and National Delegates Conference may direct,

The Deputy Presidents shall deputize the Party President.

**iii The Secretary General**

There shall be a Secretary General and two Deputies of the Party:

1. The Secretary General shall be;
  - a) The principal executive and accounting officer of the party;
  - b) The head of the Secretariat;
  - c) Secretary to Delegates Conference;
  - d) Responsible for compliance with all legal obligations of the party;
  - e) The custodian of the Party Seal;
  - f) Responsible for maintaining the corporate image of the party;
  - g) Responsible for such other activities as may be assigned from time to time.
2. National Secretariat:
 

There shall be a national secretariat under the direct supervision of the Secretary General to:

  - a) Implement the policies of the Party;
  - b) Implement decisions of the National Delegates Conference, National Council and National Executive Committee;
  - c) Provide secretarial and administrative services to the organs of the party;
  - d) Prepare policy papers as instructed;
  - e) Provide support staff to the national offices;
  - f) Constantly liaise with District branches;
  - g) Ensure safe custody of the property of the party;
  - h) Carry out any other functions as may be mandated.

The Secretariat required staff shall be recruited by an appointments committee to serve on such terms as the National Executive Committee may determine.

The National Secretariat shall consist of the following staff:

- a) Chief Administrative Officer.
- b) Legal officer.
- c) Finance and Administration Officer.
- d) Research and Policy Officer.
- e) Mobilization Officer.
- f) Information Officer.

**iv. Treasurer General**

There shall be a Treasurer General and two Deputies of the Party.

The Treasurer General shall—

- a) Be responsible for the party finances.
- b) Maintain an accurate record of the party assets and liabilities.
- c) Prepare the budget of the party.

- d) Oversee the fundraising activities of the party.
- e) Be an *ex officio* member of the special organs of the party.

## 28. THE PARTY ELECTORAL COMMISSION

There shall be established an Electoral Commission of the Party comprising the Chief Electoral Commissioner and not less than three other commissioners elected by the National Delegates Conference.

The Electoral Commission shall—

- a) Organize, manage and oversee all party elections,
- b) Liaise with the National Electoral Commission on all matters concerning elections,
- c) Maintain records of all National and Party Elections,
- d) Issue Electoral Guidelines with the approval of the National Executive Committee,
- e) In liaison with the legal department, advise on the filing of election petitions,
- f) Oversee the training, placement of agents, electoral monitors and supervisors at national and party elections,
- g) Be in charge of voter and civic education. The Electoral Commission shall be assisted by an Electoral Committee.

Amend article 28 by;

- (a) Replacing (ii) with the following;

**Whenever any office falls vacant the same shall be filled in accordance with the provisions of this Constitution in respect to the procedure in which such office was first filled. Where it is impractical to do so by reason of difficulty in convening the relevant organ, a person shall be appointed by the National Executive Committee to act in that capacity pending the decision of the relevant organ.**

- (b) Introducing a new clause to read;

**An office in the party shall fall vacant if the relevant organ passes a vote of no confidence in the holder of the office following the procedure set out under rules of procedure prescribed by the National Executive Committee.**

## CHAPTER SEVEN

- (i) Rename as "Chapter EIGHT."
- (ii) In article 29 (1) delete the words "which meets once every two years."
- (iii) In article 29 (2) replace the words "bi-annually" with the words "once a year."
- (iv) In article 29 (3) replace the words "bi-annually" with twice a year" and delete the word "also" appearing therein.
- (v) Replace article 29 (6) with the following;

**The quorum of all meetings shall be one third, provided that nothing shall prevent a meeting with less than one third from transforming itself into a working committee for deliberations to be submitted to a subsequent meeting.**

**Decisions shall be by consensus where possible and by simple majority if consensus is not reached within reasonable time.**

- (vii) Insert the clause "Notice shall be published in Newspapers, announced on airwaves or communicated by way of letter."

## PRIMARY ELECTIONS

The following shall constitute the Electoral College for Party Primaries;

### i. Parliamentary Primaries

There shall be primaries held to determine the party candidate for each Parliamentary Constituency.

The Electoral College shall be constituted by the following:

- 1. Chairpersons of the Polling Area Committees,
- 2. All Parish Executive Committees,
- 3. All Sub County Executive Committees, and
- 4. The Constituency Executive Committee.

### ii. District Woman Member of Parliament and District Chairperson

There shall be primaries held to determine the party candidate for the woman member of parliament per district and the district chairperson.

The Electoral College shall be constituted by the following:

- 1. All sub-county Executive Committees;
- 2. All the Constituency Executive Committee; and
- 3. All District Executive Committees.

### iii. City Mayor

There shall be primaries held to determine the party candidates for City Mayor.

The Electoral College shall be the Division executive committees.

### iv. Sub-County Chairpersons and District Councilors

There shall be primaries held to determine the party candidate for both the sub-county chairperson and District councilors.

The Electoral College shall be constituted by the following—

- 1. Chairpersons of the Polling Area Branches,
- 2. all Parish Executive Committees, and
- 3. Sub- County Executive Committees.

### v. Sub-County Councillors

There shall be primaries held to determine the party candidates for the sub-county.

The Electoral College shall be constituted by the following—

- a) All Polling Area Executive Committees.
- b) Parish Executive Committee.

**ADMINISTRATIVE UNITS**

There shall be primaries held to determine party candidates at Local Council 1, 2 and 4.

- a) Local Council 1  
The Electoral College is all members of PAB for villages under its jurisdiction.
- b) Local Council 2  
The Electoral College shall be the Parish Conference.
- c) Local Council 4  
The Electoral College shall be the constituency Conferences within the county.  
  
The Electoral College shall be constituency conferences within the county.

**CHAPTER EIGHT**

- (i) Rename this chapter as "Chapter Ten."
- (ii) Immediately under "Party Funds" insert "Sources of Funds."
- (iii) Insert two new sources of funds as "insert."
- (ii) Insert the words "sale of assets" before the word "Publications."
- (v) In article 31 (2) insert the word:
  - (a) "manuals" after the word "procedures", delete the words "by the Executive Committee and ratified."
  - (b) Substitute the word "Conference" with the word "council."
- (vi) Replace 31 (3) with the following:
 

"The party shall open accounts in banks approved by the National Executive Committee."
- (vii) Insert two new clauses to read; "4 The party shall have authority to borrow funds for its activities".  
And  
"5 the party shall maintain a register of party assets."

**Miscellaneous Provisions**

- (i) Rename this Chapter to 11.
- (ii) Delete article 32 (1), (2) and (5).
- (iii) Insert the following clauses in article 33;
  - (a) An amendment may be proposed by the National Executive Committee to the National Council. National Council on approval shall forward it to the Delegates Conference.
  - (b) Any member may propose an amendment of the constitution to the National Executive Committee.
  - (c) No amendment shall be introduced in the National Delegates Conference unless the proposer has given a 3 months notice of the proposed amendment in writing to the Secretary General.
  - (d) A proposed amendment in (c) above may be amended without notice.
- (iv) Delete article 35.

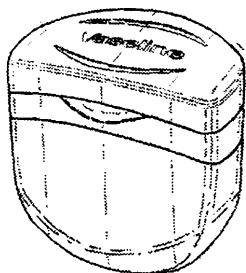

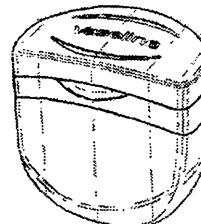


