

IN EXERCISE of the powers conferred upon the Minister by section 41 (1) of the Uganda Road Fund Act, 2008, this Order is made this 12th day of July, 2010.

1. Title.

This Order may be cited as the Uganda Road Fund (Designation of Agencies) Order, 2010.

2. Commencement.
