





**The Stamps (Exemption from Stamp Duty) (Exemption of Roofings Rolling Mills Limited from Payment of Stamp Duty in respect of the loan from International Finance Corporation) Instrument, 2011.**

*(Under section 10 of the Stamps Act, Cap. 342).*

IN EXERCISE of powers conferred upon the Minister responsible for Finance under section 10 of the Stamps Act, this Instrument is made this 28th day of April, 2011.

**1. Title.**

This Instrument may be cited as the Stamps (Exemption from Stamp Duty) (Exemption of Roofings Rolling Mills Limited from Payment of Stamp Duty in respect of the loan from International Finance Corporation) Instrument, 2011.
