





- I shall at all times hereafter in all records, deeds and documents and other writings and in all actions and proceedings as well as in all dealings and transactions and on all occasions whatsoever use and subscribe the said name of MWESIGWA DEO as my name in substitution for my former name DYONISIUS BYARUGABA so relinquished as aforesaid to the intent that I may hereinafter be called, known or distinguished not by my former name of DYONISIUS BYARUGABA but by the name MWESIGWA DEO.
- I authorize and require all persons at all times, to designate, describe and address me by the adopted name of MWESIGWA DEO.
