### **The Petroleum (Marking and Quality Control) (Amendment) Regulations, 2012**

*(Under section 6(2) (a) and section 44 of the Petroleum Supply Act, 2003, Act No. 13 of 2003)*

IN EXERCISE of the powers conferred upon the Minister by sections 6 and 44 of the Petroleum Supply Act, 2003, these Regulations are made this 25th day of September, 2012.

**1. Title.**

These Regulations may be cited as the Petroleum (Marking and Quality Control) (Amendment) Regulations, 2012.

**2. Commencement.**

These Regulations shall come into force on the 1st day of October, 2012.

**3. Amendment of regulation 9.**

The Petroleum (Marking and Quality Control) Regulations, 2009, S.I. No. 56 of 2009, in these Regulations referred to as the principal Regulations are amended in regulation 9 (1) as follows—

- (a) by substituting for the word “*inspector*”, the word “*officer*”; and
- (b) by repealing paragraph (a).

**4. Amendment of regulation 10.**

Regulation 10 of the principal Regulations is amended in subregulation (1) (c) by inserting the words “*from the date of marking*” immediately after the word “*days*”.

**5. Amendment of regulation 11.**

Regulation 11 of the principal Regulations is amended by substituting for the word “*five*” the word “*ten*”.
