NOTICE

POLICY GUIDELINES FOR THE
IMPLEMENTATION OF A ONE NETWORK AREA
WITHIN THE NORTHERN CORRIDOR REGION

IN EXERCISE OF the powers conferred upon the Minister of Information and Communications Technology by section 7 of the Uganda Communications Act, the following policy guidelines are issued—

Uganda Communications (One Network Area) Policy Guidelines.

Background

These Ministerial Policy Guidelines are issued this 23rd day of July, 2014, pursuant to section 7 of the Uganda Communications Act, 2013, to give effect to the decision of the 5th Heads of State Summit for the Northern Corridor Integration Projects held in Nairobi, Kenya, on 2nd May, 2014 and the 6th Heads of State Summit held in Kigali, on 3rd July, 2014, on the implementation of a One Network Area for the Northern Corridor Region.

WHEREAS the Member States of the Northern Corridor, namely, The Republic of Kenya, The Republic of Rwanda, The Republic of Uganda and The Republic of South Sudan adopted a regional telecommunications framework for the implementation of a “One Network Area” within the Northern Corridor Region as agreed during the 5th Heads of State Summit for the Northern Corridor Integration Projects held in Nairobi, Kenya, on 2nd May, 2014;

WHEREAS during the 6th Heads of State Summit held in Kigali, Rwanda, on 3rd July, 2014, it was agreed that the three Member States, namely: The Republic of Kenya, The Republic of Rwanda and The Republic of Uganda shall implement the “One Network Area” by 31st December, 2014;

NOW THEREFORE, pursuant to the decision of the 5th Heads of State Summit for the Northern Corridor Integrated Projects held in Nairobi, Kenya, on 2nd May, 2014 and the 6th Heads of State Summit held in Kigali on 3rd July, 2014, on the implementation of a One Network Area for the Northern Corridor Region;

AND in accordance with section 7 of the Uganda Communications Act, 1 of 2013, there shall be adopted for the implementation of the “One Network Area” by all telecom operators for traffic originating and terminating within the Northern Corridor Region, the following Policy Guidelines—

1. Exemption of regional calls from surcharges which are applied on international incoming calls.
2. Removal of additional charges to subscribers on account of roaming within the region;
3. Removal of charges for receiving calls while roaming within the region;
4. Subscribers travelling within the region will be charged as local subscribers in the visited country network. The subscriber will, therefore, only incur prevailing calling rates of the visited network similar to what local subscribers pay; and
5. Operators within the region shall be required to renegotiate their bilateral agreements to ensure full implementation of the One-Network Area by 1st September, 2014, for Kenya, Rwanda and Uganda, and 31st December, 2014, for South Sudan.

These Guidelines may be cited as the Uganda Communications (One Network Area) Policy Guidelines 2014, and take effect on 1st September, 2014.
