**The Electoral Commission (Appointment of Date of Completion of Update of Voters' Register for the election of Administrative Units Chairpersons and Women Councils/Committees countrywide) Instrument, 2018.**

*Under Section 19 (8) (a) of the Electoral Commission Act, Cap 140, and Section 6 A (a) and (c) of the National Women's Council Act, Cap 318.*

IN EXERCISE of the powers conferred upon the Commission under Section 19 (8) (a) of the Electoral Commission Act, Cap 140 (as Amended) and Section 6A (a) of the National Women's Council Act, Cap 318, this Instrument is made this 28th day of May, 2018.

**1. Title.**

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register for the Election of Administrative Units Chairpersons and Women Councils and Committees countrywide) Instrument, 2018.

**2. Appointment of date of completion of registration.**
