 - (i) The parties agree that plot of land located at Busasa Plot 670, Block 183, on which rental units have been constructed be transferred and registered in the names of the children for their benefit.
 - (ii) That the Respondent buys out the interests of the Petitioner in the plot of land located at Seguku on Plot 963, Block 377, at Ugx 7,500,000/= (*Seven Million Five Hundred Thousand Shillings*).
4. That the duty of maintaining the children shall be the responsibility of both the Petitioner and the Respondent but their roles outrightly displayed as below;
 - The Petitioner shall continue to pay school fees together with general maintenance of the children while the Respondent shall handle medical and the feeding of the children.
5. That the Petitioner shall meet the costs of this petition.
