This Policy Direction is given to the Electricity Regulatory Authority under section 17 of the Electricity Act, 1999, Cap 145, this 3rd day of August, 2018 2 KISA LAWRENCE GJOK

PREAMBLE

- 1. WHEREAS the Government of Uganda has put in place a plan in the National Oil and Gas Policy for Uganda, 2008 to develop its petroleum resources, the key aspects of which include the development of an oil refinery, the construction of a crude wit export pipeline and the production of oil for power generation;
- 2. WHEREAS the Government strategy in the National Oil and Gas Policy for Uganda 2008 is to use oil and gas resources to contribute to the country's energy mix by promoting the use of some of the crude oil, excess gas and Heavy Fuel Oil (HFO) from the oil refinery activities in the generation of electricity with a view to ensuring adequate and affordable energy supply;
- 3. WHEREAS the Government had a target to produce the first oil by 2018 but due to a number of factors, this target will not be achieved and the revised petroleum production plans in line with the first oil is scheduled POLITICAL PARTY/ 211for 2020;
- 4. AND WHEREAS the Minister of Energy and Mineral Development issued to the Electricity Regulatory Authority a "Policy Direction relating to the Development of Power Plants to Utilize Indigenous Oil resources" on the 5th May, 2017, under General Notice No. 363 of 2017; 4. MUTASINGWA DIANA
- NOTING that as a result of Government projections, Albatros Energy Uganda Ltd. was licensed under the Electricity Act, 1999, to develop a power plant to utilize indigenous Ugandan Petroleum resources; IBMIVIX
