The Security Organisations (Terms and Conditions of Service) (Amendment) Regulations, 2018.

(Under sections 9 and 12(b) of the Security Organisations Act, Cap. 305)

IN EXERCISE of the powers conferred upon the Minister responsible for Security, by sections 9 and 12(b) of the Security Organisations Act, Cap 305, these Regulations are made this 25th day of August, 2018.

1. Title

These Regulations may be cited as the Security Organisations (Terms and Conditions of Service) (Amendment) Regulations, 2018.

2. Commencement.

These Regulations shall be deemed to have come into force on the 1st day of July, 2017.

3. Amendment of S.I 305-1

The Security Organisations (Terms and Conditions of Service) Regulations, referred to as the principal Regulations are amended in regulation 3—

(a) by substituting for paragraph (e) the following –

“(e) “family” means spouse, a biological child or an adopted child of an officer or employee of security organisation;”

(b) by inserting immediately after paragraph (h) the following

—
“(ha) “pensionable emoluments” means emoluments that may be taken into account in the computation of retirement benefits and includes salary but does not include duty allowance, house allowance, entertainment allowance or any other emoluments;”

- “(hb) “pensionable office” means service in the security organisation to which an officer or employee has been appointed by the authority having power for the time being to make appointments to the security organisation on terms which include eligibility for the grant of a pension under these Regulations;”
- (hc) “pensions authority” means the permanent secretary in the ministry responsible for security;
- (hd) “qualifying service” means service which may be taken into account in determining whether an officer is eligible by length of service for pension or gratuity;
- “(he) “salary” means the salary attached to a pensionable office or, where provision is made for taking service in a non-pensionable office into account as pensionable service, the salary attached to that office;”

5. Amendment of regulation 4.

Regulation 4 of the principal Regulations is amended by substituting for subregulation (5), the following—

“(5) Appointments to a security organisation shall be either on permanent and pensionable or non-pensionable terms.”

6. Amendment of regulation 6.

Regulation 6 of the principal Regulations is amended in sub regulation (1), by substituting for the words “*one year*,” appearing between the words “*of*” and “*which*” with the words “*six months*,”.

7. Amendment of regulation 14.

Regulation 14 of the principal Regulations is amended by substituting for subregulation (3), the following—

“(3) Confirmation of appointment under this regulation shall be communicated in writing to the officer or employee concerned, thirty days after the expiry of the probation period and shall be with effect from the date of appointment on probation.”

8. Amendment of regulation 16.

Regulation 16 of the principal Regulations is amended by revoking subregulation (3) (b).

9. Insertion of a new regulation 29 A.

The principal Regulations are amended by inserting regulation 29A immediately after regulation 29, the following-

“29A. Paternity leave

A male officer or an employee of a security organisation is entitled to a paternity leave of four working days on full pay immediately after delivery or miscarriage of his wife.”

10. Amendment of regulation 32.

Regulation 32 of the principal Regulations is amended in subregulation (1), by substituting for the word “*fifty*” appearing between the words “*of*” and “*years*” with the word “*sixty*”.

11. Revocation of regulation 36 and 37.

The principal Regulations are amended by revoking regulation 36 and 37.

12. Insertion of a new regulation 38 - 54.

The principal Regulations are amended by inserting immediately after regulation 37, the following—

“38. Pensions to whom and at what rates to be granted.

Subject to these Regulations, every officer or employee holding a pensionable office in the security organisation, who has been in such service for ten years or more, may be granted on retirement a pension at the annual rate of one five-hundredth of his or her pensionable emoluments for each completed month of his or her pensionable service.

39. Gratuities where length of service does not qualify for pension.

Every officer or employee, otherwise qualified for a pension, who has been in service for less than ten years may be granted on retirement a gratuity not exceeding five times the annual amount of the pension which, if there had been no qualifying period, might have been granted to him or her under regulation 38 of these Regulations.

40. General rules as to qualifying service and pensionable service.

(1) Subject to these Regulations, qualifying service shall be the inclusive period between the date on which an officer or employee begins to draw salary in respect of service in security organisation and the date of his or her leaving the security organisation, without deduction of any period during which he or she has been absent on leave.

(2) No period which is not qualifying service by virtue of Regulation 40(1) of these Regulations shall be taken into account as pensionable service.

(3) No period during which the officer or employee was not in the Security Organisation shall be taken into account as qualifying service or as pensionable service.

41. Continuity of service.

(1) Except as otherwise provided in these Regulations, only continuous service shall be taken into account as qualifying service or as pensionable service except that any break in service which—

- (a) does not arise from misconduct or voluntary resignation; or
- (b) has been approved by the pensions authority on any reasonable grounds shall be disregarded for the purposes of this subregulation.

(2) An officer or employee who has retired from the Security Organisation without pension on account of ill health, abolition of office, or reduction in force designed to effect greater efficiency or economy, and has subsequently been reemployed in the Security Organisation may, if the pensions authority thinks fit, be granted the pension or gratuity for which he or she would have been eligible if any break in his or her service immediately prior to such reemployment or employment had not occurred.

42. Leave without salary.

No period during which an officer or employee has been absent from duty on leave without salary shall be taken into account as pensionable service unless the leave has been granted on grounds of public policy with the approval of the pensions authority.

43. Computation of pension or gratuity.

(1) For the purpose of computing the amount of the pension or gratuity due to an officer or employee under these Regulations, the full annual pensionable emoluments enjoyed by him or her immediately prior to the date of his or her retirement shall be taken into account.

(2) The entire length of service in the security organisation shall be taken into account for purposes of computing retirement benefits of an employee or officer serving in a security organisation.

44. Adjustment of pensionable emoluments

Pensionable emoluments payable in a financial year shall be adjusted by the pensions authority based on the annual rate of inflation as declared by the Uganda Bureau of Statistics at the end of the previous financial year.

45. Service otherwise than in a pensionable office.

Only service in a pensionable office shall be taken into account as pensionable service.

46. Retirement on abolition of office or compulsory retirement

If an officer or employee holding a pensionable office retires from the security organisation as a consequence of abolition of office, he or she may—

- (a) if he or she has been in the service for less than ten years, be granted in lieu of any gratuity under regulation 39 of these Regulations, a pension under regulation 38, of these Regulations, as the case may be, as if the words “for ten years or more” were omitted from regulation 38;
- (b) if he or she retires from the security organisation, be granted an additional pension at the annual rate of one-quarter of the pension for which he or she would be eligible under regulation 38, of these Regulations, except that the addition together with the remainder of the officer or employee’s pension shall not exceed the pension for which he or she would have been eligible if he or she had continued until the retirement age.

47. Severance pay for officers or employees retired on abolition of office.

Where an officer or employee holding a pensionable office ceases to hold that office as a result of abolition of office, that officer or employee shall be paid severance pay at a rate applicable in security organisation.

48. Gratuity and reduced pension.

(1) Any officer or employee to whom a pension is granted under these Regulations may, at his or her option exercisable not later than the day immediately preceding the date of his or her retirement from the security organisation, or at such later date as the pensions authority may in any special case approve, be paid in lieu of such pension, a pension at the rate of two-thirds or any greater of such pension together with a gratuity equal to fifteen times the amount of the reduction made in the pension.

(2) In the application of this regulation to cases where the limitation prescribed by subregulation (1), operates the words “such pension” shall mean the amount of pension which the officer or employee would have drawn from the public funds of Uganda if he or she had not exercised his or her option under this regulation.

(3) Where an officer or employee has exercised the option mentioned in subregulation (1), he or she may, not later than the day immediately preceding the date of his or her retirement from the service or such later date as the pensions authority may in any special case approve, amend or revoke the option.

49. Identification

A person to whom pension, gratuity or other allowance has been granted under these Regulations shall, before any such pension, gratuity or allowance is paid to him or her, satisfy the pensions authority as to his or her identity.

50. Pensions, etc. not to be assignable.

Pension or gratuity granted under these Regulations shall not be assignable or transferable except for the purposes of satisfying—

- (a) a debt due to the Government; or
- (b) an order of any court for the payment of periodical sums of money towards the maintenance of the wife, or former wife or minor child of the officer or employee to whom the pension or gratuity has been granted.

51. Pension not subject to attachment on bankruptcy.

Where any person to whom a pension has been granted under these Regulations is adjudicated bankrupt or is declared insolvent by judgment of any competent court, the officer or employee shall continue to receive the pension or gratuity, but the pension or gratuity shall not be subject to attachment under the Insolvency Act, 2011.

52. Gratuity where officer or employee dies.

Where an officer or employee dies while holding a pensionable office and is not on probation or while holding a non-pensionable office to which he or she has been transferred from a pensionable office in which he or she has been confirmed, the pensions authority may grant to his or her legal personal representatives—

- (a) if the officer or employee had served in the security organisation for ten years or less—
 - (i) a gratuity of an amount not exceeding three times his or her annual pensionable emoluments; or
 - (ii) a gratuity of an amount not exceeding five times the annual amount of pension the deceased officer or employee would have been eligible for if his or her period of service had been qualifying service for the purpose of these Regulations.
- (b) if the officer had served in the security organisation for a period exceeding in the aggregate ten years—

- (i) either a gratuity of an amount not exceeding triple his or her annual pensionable emoluments or his or her commuted pension gratuity, whichever is the greater; or
- (ii) a reduced pension as provided in regulation 48 of these Regulations whether commuted pension gratuity under paragraph (b)(i) of this sub-regulation is payable or not; and for the purpose of granting a pension under this subparagraph—
 - (aa) if the deceased officer or employee is survived by a spouse, pension shall be payable to the surviving spouse for a period not exceeding fifteen years from the date of death of the officer;
 - (bb) if the deceased officer or employee leaves a child or children, but does not leave a spouse, pension shall be payable to the child or children for a period not exceeding fifteen years;
 - (cc) if the deceased officer or employee leaves any child and a spouse to whom a pension is granted under subparagraph (ii) (a) of this regulation, and the spouse subsequently dies within fifteen years from the date of death of the officer or employee, the provisions of subparagraph (ii)(b) of this regulation shall apply for the unexpired period of the fifteen years;
 - (dd) if the deceased pensioner is survived by more than one wife or child, the amount of any pension, gratuity or other allowance shall be divided equally among the wives or children;

- (ee) pension granted under sub-regulation (1), (b)(ii) shall not be payable for a period exceeding, in aggregate, fifteen years.

53. Pensions, etc. to cease on death.

(1) Pension or other allowance granted under these Regulations, shall unless it has sooner ceased, cease upon the death of the person to whom it is granted.

(2) Notwithstanding subregulation (1), where a person who is in receipt of a pension under these Regulations dies before the expiry of fifteen years after the date of his or her retirement, the pensions authority may continue paying the pension—

- (a) if the deceased pensioner is survived by a spouse, to the spouse, for the unexpired period of the fifteen years;
- (b) if the deceased pensioner is not survived by a spouse, to a child or children, for the unexpired period of the fifteen years;
- (c) if the deceased pensioner is survived by a spouse to whom a pension is granted under paragraph (a) of this subregulation and a child or children, and the spouse subsequently dies before the expiry of the remainder of the fifteen years, then paragraph (b) of this subregulation shall apply.

(3) For the avoidance of doubt, pension granted under these regulations shall be payable for a period not exceeding in aggregate fifteen years from the date of retirement of the deceased pensioner.

54. Minimum pension

(1) Pension granted to an officer or employee under these Regulations shall not be less than a quarter of the last pensionable emoluments at the time of retirement.

(2) The minimum pension provided under subregulation (1), shall apply only if the option of advancing a gratuity has not been exercised by the officer or employee.
