The Local Governments (Kiboga Town Council) (Miscellaneous) Bye-Law, 2018.

(Under section 39 of the Local Governments Act, Cap. 243)

IN EXERCISE of the powers conferred upon the Kiboga Town Council by section 39 of the Local Governments Act, this bye law is enacted this 14th day of November, 2017.

BE IT ORDAINED by the council of Kiboga Town Council as follows:

PART I—PRELIMINARY.

1. Title

This Bye-law may be cited as Local Governments (Kiboga Town Council) (Miscellaneous) Bye-law, 2018.

2. Objective.

The objectives of this Bye-law is intended to regulate—

- 1) The parking of motor vehicles, motorcycles and bicycles on streets and other designated parking areas;
- 2) The conduct of business by street traders; and
- 3) Operations of dancing halls, bars and shops;
- 4) Ensuring that animals are not kept in town.
- 5) Compliance with the building rules and regulations and other illegal activities in Kiboga Town Council with a view to maintaining cleanliness, orderliness and safeguarding the lives of the residents, children and other occupants of Kiboga Town Council; and to raise local revenue for general service delivery in the town council.

3. Application

This Byelaw applies to the area of jurisdiction of Kiboga Town Council.

4. Interpretation

In this Bye-law, unless the context otherwise requires—

- a) “Act” means the Local Governments Act;
- b) “Agent” means a person duly appointed by the council
- c) “Boda boda” means any bicycle or motor cycle that is hired for private transport for a fee;
- d) “Council” means Kiboga Town Council;
- e) “Currency point” has the value assigned to it in schedule 1 to this Bye-law;
- f) “Other designated parking place” includes a parking place which does not form part of a road or any other parking as may be designated by the Council from time to time.
- g) “street trader” means a propeller of a wheelbarrow, shoe repairer, shoe polisher, watch repairer, newspaper or book seller or charcoal seller carrying on business on a street or any other public place and
- h) “vehicle” includes a machine or implement of any kind drawn or propelled along roads, whether by animals, mechanical, electrical or any other motive power.
- i) “animals means cattle, goats, sheep or pigs.
- j) “other animals includes dogs, cats, donkeys, horses , rabbits, rats.
- k) “planned area means area designated by council for residential, industrial or other specified purposes;
- l) “cash crops “ crops meant for sell

PART II—MANAGEMENT AND OPERATION OF STREETS AND OTHER DESIGNATED PARKING AREAS.

5. Appointment of an agent.

The council shall appoint an agent to carry out on its behalf, the functions conferred upon the council by this bye-law.

6. Authorized parking.

The parking of vehicles in Kiboga town shall only be in designated street parking places or other designated parking places.

7. Zoning of parking places.

The council shall, from time to time, demarcate parking areas within Kiboga town council.

8. Control of parking places.

For avoidance of doubt, the control and management of parking areas within Kiboga Town Council shall be by the Council or its agent.

9. Parking fees.

The council shall fix, and may from time to time vary fees and charges in respect of parking under this Bye-law.

The Council or its agent shall issue a parking invoice to a person who parks a vehicle in a street or other designated parking place and that person shall pay the prescribed parking fee.

10. Loading and offloading of passengers.

(1) A person operating a transportation business shall not load or offload passengers at any other place except in the bus park, taxi park or any other place designated by the council for this purpose.

(2) A person who contravenes sub rule (1) commits an offence and is liable on conviction be to a fine not exceeding two currency points or a jail term not exceeding six months or both.

11. Loading or offloading fees.

(1) The council shall fix, and may from time to time vary fees and charges in respect of loading or offloading passengers or cargo in the park.

(2) The council or its agent shall issue a loading or offloading invoice to a person whose vehicle entrees the park and that person shall pay the prescribed loading or offloading fee.

12. Powers of council to tow or remove vehicle of motorcycle.

Where a person parks a vehicle or motorcycle in an area not designated as a parking place, the council shall tow or remove the vehicle or motorcycle from that place and the owner of the vehicle or motorcycle shall pay to the council or its authorized agent the expenses incurred in towing or removing the vehicle.

PART III—REGULATION OF SPECIAL HIRE TAXI AND
BODA-BODA BUSINESS.

13. Special hire taxi permit.

(1) A person shall not operate a special hire taxi with the council unless he or she is in possession of a valid permit issued by the council or its authorized agent.

(2) A person operating a special hire taxi shall not use any area within the council as a parking stage unless that area is designated and approved by the council as a parking stage.

14. Boda – boda permit.

(1) A person shall not operate a boda-boda within the council without a permit issued by the council.

(2) A person operating a boda-boda shall not use any area within the council as a parking stage unless that area is designated and approved by the council to be used as a parking stage.

15. Badges.

(1) The council shall issue to a successful applicant for a special hire taxi permit or a boda-boda permit, a numbered badge in such form as the council may determine.

(2) A special hire taxi operator or a boda-boda operator to whom a badge has been issued under this Bye law shall display the badge in a conspicuous part on his or her person at all times when carrying out his or her operations as a special hire taxi or boda-boda operator.

16. Uniform

A special hire taxi operator or boda-boda operator permitted to operate under this ordinance shall at all times wear a uniform approved by the council when carrying on his or her duties.

PART V – REGULATION OF STREET TRADERS/VENDORS.

17. Prohibition of street trading without permit.

(1) No person shall carry out street trade or any business on the street of Kiboga town council without permission.

(2) The form of permit to be issued to street traders shall be as set out in the first schedule to these byelaws.

18. Proper structures, kiosks or premises to be provided.

(1) A holder of a permit referred to in rule 17 above shall at his or her own expense, set up a structure, kiosk or premises for conducting his or her business.

(2) The council or its authorized agent shall inspect and either approve or reject the structure, kiosk or premises.

PART VI—GENERAL PROVISIONS RELATING TO PERMITS.

19. Application for permit.

(1) A person intending to operate a special hire taxi or a boda-boda shall upon payment of a non – refundable application fee prescribed in schedule 2, apply to the council for a permit.

(2) An application under sub rule (1) of this rule shall be accompanied by an introduction letter from the local council chairperson of the applicant’s place of residence and indicate—

- (a) The name of the applicant;
- (b) The physical and postal addresses of the applicant and
- (c) The location where the applicant intends to operate.

(3) Upon receipt of an application, the council; shall asses the suitability of the applicant bearing in mind the security and public health needs of the community and where the council shall from time to time decide.

(4) Where the council rejects the application for a permit under this rule, the council shall within seven working days of the decision communicate the decision, reasons for refusal and any remedies available to the applicant if applicable.

(5) A person aggrieved by the decision under sub rule (4) above shall have the right to appeal to the town clerk within ten working days of receipt of the decision.

(6) A permit issued under this rule shall be valid for one year from the date of issue after which, the permit holder shall apply to the council for renewal using a procedure similar to that of initial application.

20. Failure to comply with permit conditions.

A person who contravenes or fails to comply with the conditions attached to the permit commits an offence and is liable on conviction to a fine not exceeding one thousand shillings or to a term of imprisonment not exceeding two months or to both.

21. Permit not to be let, hired, etc and to be produced on demand.

(1) A person shall not let, hire, lend or sell his or her permit to any other person.

(2) A holder of a permit issued under these byelaws shall produce and show his or her permit to a police officer or an authorized officer of the council on demand.

22. Cancellation of permit.

The council may, in addition to any other punitive or disciplinary action taken under these byelaws, cancel any permit in the case of contravention of these byelaws or breach of any conditions attached to the permit.

PART VI—REGULATION OF DANCING HALLS AND BARS.

23. Dancing halls to be licensed.

A person shall not use any premises for holding dances to which the public is admitted, whether on payment or otherwise, unless there is in force in respect of those premises a valid dancing hall license issued by the council.

24. Application for a dancing hall license.

(1) A person intending to operate a dancing hall or hold a dance shall upon payment of a non-refundable application fee prescribed in schedule 2, apply to the council for a license

(2) An application under subrule (1) of this rule shall be accompanied by an introduction letter from the local council chairperson of the applicant's place of residence and indicate—

- (a) The name and address of the applicant; and
- (b) The physical address of the premises for which the license is being sought.

(3) Upon receipt of an application, the council shall assess the suitability of the premises bearing in mind the security and public health needs of the community and where the council is satisfied with the application, grant a license in the format that the council shall from time to time decide.

(4) A dancing hall licence may—

Be issued subject to such conditions as the council may think fit to impose and be either annual in which case, it shall be valid for a period of one year from the date of its issue or occasional, being valid only for the occasion in respect of which it is granted and for the period stated in the license.

25. Refusal to grant dancing hall license.

(1) The council may refuse to issue a dancing hall license if it is of the opinion that—

- (a) The premises in respect of which the license is sought are not suitable for the purpose;
- (b) No adequate sanitary arrangements for both sexes are provided;
- (c) The issue of the license would likely cause substantial inconvenience to neighboring residential premise or other facility; or
- (d) The premises to which the license relates have been previously licensed and have not been maintained at a standard which, in the opinion of the council, is satisfactory.

(2) Where the council rejects the application for a license under this rule, the council shall within seven working days of the decision

communicate the decision, reasons for refusal and any remedies available to the applicant if applicable.

(3) A person aggrieved by the decision under sub rule (2) above shall have the right to appeal to the town clerk within ten working days of receipt of the decision.

26. Premises and maximum number of persons to be specified.

(1) A dance shall not take place at any premises licensed under this Byelaw except in accordance with the number of attendees and other terms and conditions specified in the dancing hall license relating to the premises.

(2) In every dancing hall license there shall be affixed in a conspicuous place, a notice of the maximum number of persons who may at any one time use it for dancing.

27. Licensee's responsibilities.

The person to whom a dancing hall licence is issued shall be responsible for the maintenance of order and for compliance with this Byelaw and for the observance of the terms and conditions of the license.

28. No. Liquor without a liquor license.

A person shall not take into or consume liquor in premises licensed under this part of the Bye law during a dance to which the public is admitted except where the dancing hall license specifically permits it.

29. Regulation of bar business.

(1) A bar owner or tender shall not open the bar premises to business except between the hours of 3:00 pm and midnight.

(2) A bar owner or tender shall not allow a child entry into his or her premises.

(3) A bar owner shall indicate clearly at the bar entrance the age limit of the persons allowed into the premises.

(4) A bar owner or tender who contravenes any provision of this rule commits an offence and is upon conviction liable to a fine not exceeding two currency points or a jail term not exceeding six months or both.

PART VII—KEEPING OF ANIMALS WITHIN THE COUNCIL

30. Keeping or grazing animals.

No person shall be allowed to graze any animal within the C.B.D (central business district) in the following areas of council.

- (a) Kabaka Njagala Cell Bamusuuta Ward.
- (b) Bamusuuta Trading Centre Bamusuuta Ward.
- (c) Lufula cell Kilulumba Ward.
- (d) Kiboga I.C.I Cell Kiboga Ward.
- (e) Buzibwera L.C.I Cell Buzibwera Ward.

31. Impounding of animals.

- (a) The council shall impound any animals kept or found grazing in the prohibited area of the council and the animals shall be taken to a pound set aside for that purpose.
- (b) No person shall take any animal that has been impounded under this Byelaw from the pound except with the permission of the pound keeper and on payment of a fine of twenty thousand per day if it is a cow, fifteen thousand per day if it is a sheep, a goat and a pig.
- (c) Any person who attempts to break into the pound commits an offence and is liable on a conviction to a fine of not more than forty thousand shillings and may also be ordered to pay for the damages caused to the pound as a result of the break in or attempted break in.

32. Keeping other animals

(1) Any person who keeps other animals such as carts, dogs, donkeys, horses and rabbits within the prohibited areas shall register the other animals with council.

(2) The council shall not register a dog unless its owner produces a valid certificate signed by a veterinary officer to the effect that the dog has been inoculated against rabies.

33. Compliance with the Byelaws.

Every person who erects a building in the council shall comply with the requirement of these byelaws or any other laws.

34. Notice of erecting or making alterations to building.

(1) Any person who intends to erect a building or make any alteration to a building in the council shall submit to the council a notice in writing of his or her intention to do so together with the building plan.

(2) Any person who contravenes this byelaw commits an offence and is liable on a conviction to a fine not more than forty thousand shillings.

(3) In addition to the fine in sub byelaw (2) of this byelaw the council may demolish the affected buildings.

35. Alteration to building plans.

Any person who intends to make alterations to a building plan shall submit the offered plan to the council for approval.

36. Construction of buildings without permission .

No person shall construct buildings in the council unless he or she is issued with a permit by the council.

37. Construction of houses in certain places.

No person shall construct a houses on any site which is used as a deposit of garbage excremental matter or carcass.

38. Building on road reserves, service lanes etc prohibited.

No person shall erect a building on a road reserve sanitary lane or side lane.

39. Notice to council of stages in construction

A person whose building plans have been approved by the council shall notify the council in a prescribed form during the construction stages such as excavation and laying of foundation, placement of dam proof course, ring beams and placing wall plates.

40. Depositing materials on road reserve

(1) No person shall deposit any building materials excavated soils or any other materials on a road reserve without permission of the council.

(2) A person who contravenes this byelaw may be ordered to remove the soil materials from the road reserve.

41. Surveyors subdivision of plot.

No person shall, without the express permission of the council, surveyor subdivide a plot within the council

42. Erection of sign posts, posters etc.

(1) No person shall erect a sky-high signpost, poster or inscription on any building without permission in writing from the council.

(2) Non compliance with this byelaw may result in confliction, erasing or destruction of the sign post, poster or inscription.

43. Certificate of suitability of new buildings.

A person who intends to occupy a building after its completion shall submit to the council a certificate duly signed by a health inspector of the council confirming that the building is fit for habitation.

44. Occupation permit.

No person shall occupy a new building within the council unless he or she procures a written permit of occupation from the council

45. Undeveloped plots to be kept clean

A person who owns an undeveloped plot or piece of land within a planned area or with in the council shall keep the plot a piece of land in a hygienic and sanitary manner or alleviate overgrowth, filth harbouring of rodents, vermin, or any other related danger.

46. Expiry of a building plan.

The developer shall submit an application for renewal/re-approval of his/her building plan after very 18 months if before completion of his/her building.

PART IX—LICENSING OF TRADING PREMISES.

47. Application for license

(1) Any person who intends to operate any business within the council shall apply in a prescribed form to the council for the issue of a license.

(2) The application shall be accompanied by a fee to be determined by council.

(3) Upon receipt of the application the council shall determine the fitness of the trading premises before issuing a trading license.

48. Carrying on business without license prohibited.

No person shall carry on business unless he or she has a license issued by the council.

49. Breaking into locked premises.

Any person who breaks into trading premises closed and locked by the council commits an offence.

PART X—DRYING OF CASH CROPS AND BURNING OF GRASS.

50. Drying of cash crops.

(1) A producer of cash crops for export shall ensure that the cash crop for sale are completely dried which drying shall be done on a raised construction with in a free circulation of air underneath or on trays or on clean cemented drying floors.

(2) No person shall dry the cash crops with in the council or at the stores of the crops in the following areas

- a. Along Kampala – Hoima highway in Kiboga town
- b. Along 2nd street.
- c. Along Kiganzi road.
- d. Along 3rd street.

51. Burning of grass prohibited.

(1) No person shall burn grass or any other vegetation in any area with in council.

PART XI—EMPLOYMENT OF CHILDREN

52. No employment of children.

(1) Subject to the constitution of Uganda Article 34 & the employment Act sec. 50&51—

- (a) No person shall employ or cause to be employed or subject to work any child below the age of 16 years
- (b) No child shall be allowed to work beyond 7:00pm with or without a parent or guardian.
- (c) No child shall be allowed to work or stay in the market, bar, salon, hotel, restaurant and lodges with or with out a parent or guardian.

(2) Subject to these byelaws it shall be an offence for a child to ride a boda-boda.

53. Children not to perform at promotions .

No child shall be allowed to perform at business promotion plat form.

PART XII—RESTRICTIONS TO VIDEO, NIGHT CLUBS AND BARS.

54. Children or students prohibited from entering videos, night clubs and bars.

(1) No child or student shall be permitted in the videos, night club and bars.

(2) The operator of the club, video and bar where children and students are found commits an offence.

(3) Any child or student found in such places also commits an offence.

(4) For the purpose of these byelaws “student” means any person in primary or secondary school.

55. Market vendors not to be accompanied by children

A person who is involved in the business of selling goods in the market shall not for the period he/she is selling in the market be accompanied by a child of between 1 to 6 years.

56. Duration of permit

Any permit or license issued by the council under these byelaws shall where the duration is not specifically provided in the byelaws be issued for 1 calendar year

57. Kiboga town council Bulungi bwansi project (Keep Kiboga Clean)

(1) Every adult person of or above 18 years shall participate in the maintenance of bulungi-bwansi project in his/her village or work place.

(2) A sick person shall be exempted by the executive committee from participating in the project until he/she has recovered and is strong enough to participate in the project.

(3) The council shall declare a day in the months to be the Bulungi-bwansi day and the secretary of information shall remind the members either by calling each homestead announcements on the Bulungi – bwansi day and the members shall then convene for work.

(4) Every business holder shall be required to close his/her business for the period that shall be stipulated by council during Bulungi-bwansi day.

(5) A person who fails to participate in the Bulungi-bwansi without reasonable cause commits an offense and is liable to a fine not exceeding forty thousand shillings or imprisonment not exceeding 5 (five) days or both.

(6) Every person shall have a litter bin at his or her premises and shall be responsible for every garbage in front of his business.

58. Offences and penalties

A person who—

- (a) Parks a vehicle in a place not designated as a parking place.
- (b) Parks a vehicle improperly in a parking place in total disregard of the manner in which the parking place is marked.
- (c) Operates a special hire taxi or boda boda business without a permit issued by the council.
- (d) Being a special hire or boda-boda operator, operates without wearing a uniform or a badge;
- (e) Defaults or fails to pay any parking fees;
- (f) Operates an illegal parking place;
- (g) Engages in street trading without a permit;
- (h) Operates a dancing hall without a license; or Contravenes any rule of this byelaw for which no penalty is provided, Commits an offence and is liable, on conviction, to a fine not exceeding two currency points or a jail term not exceeding six months or both.

In addition to the penalty provided under this rule, any expense incurred by the council or its agent as a result of the breach of the provisions of this Bye law shall be paid by the person convicted and the expenses may be recovered summarily as a civil debt.


