**The Uganda Citizenship and Immigration Control (Fees)
(Amendment) Regulations, 2018.**

*(Under sections 49 and 82 of the Uganda Citizenship and
Immigration Control Act, Cap. 66)*

IN EXERCISE the powers conferred upon the Minister by sections 49 and 82 of the Uganda Citizenship and Immigration Control Act, Cap. 66, and in consultation with the National Citizenship and Immigration Board, these Regulations are made this 30th day of November, 2018.

1. Title

This Instrument may be cited as the Uganda Citizenship and Immigration Control (Fees) (Amendment) Regulations, 2018.

2. Amendment of Part I of Schedule of S.I 13 of 2016

Part I of the Uganda Citizenship and Immigration Control (Fees) Regulations, 2016, S.I No. 13 of 2016 is amended by substituting for Item 1 the following—
