





IMPLEMENTATION OF GRID-CONNECTED SOLAR PHOTOVOLTAIC AND WIND POWER (INTERMITTENT ELECTRICITY GENERATION) PROJECTS IN UGANDA

1. BACKGROUND

The Electricity Regulatory Authority (the 'Authority') having noticed increased Expression of Interest by the Private Sector to Generate Electricity by harnessing the Sun's Potential, on January 2015 issued a Regulatory Notice "ERA 001/2015" effective January 2015 in respect of the implementation of Grid-Connected Solar Power Generation Projects in Uganda.

The Authority continues to receive Expression of Interest from intending developers in Grid-Connected Solar Power and Wind Power Generation.

Whereas this is an initiative that should be encouraged and promoted, especially in view of Uganda's Solar Potential and our National Aspirations to increase Electricity Generation to stimulate Industrialization, Economic and Social development, there is need to carefully plan and match the Demand and Supply of Electricity, to remain alert and sensitive to the fluctuating cost of Solar and Wind Power, Uganda's current Generation Capacity from Operational Plants and Plants under construction, the Energy needs of the country, as well as the Technical Capability of the National Electricity Grid to absorb this power without affecting the quality of Electricity Supply.

2. RATIONALE

Continuous Technological advancements have resulted in cheaper and more efficient Solar Photovoltaic and Wind Power Technology worldwide. Benefits from these improvements can only be realized through effective management of the cost of production of Electricity from these resources.

Competitive procurement of such capacity is one of the most effective means of guaranteeing reasonable and fair pricing of Solar and Wind Power, as well as harnessing the benefits of such modular technologies, including System Loss Reduction and Voltage Stability.

From a Technical Perspective, Solar Photovoltaic and Wind Power Generation is associated with frequent power swings owing to its intermittent nature. This, therefore, calls for accurate determination of the extent to which the National Electricity Grid can accommodate the additional Power from Solar and Wind without adversely affecting the quality of Power Supply and the dynamic management and operation of the Power System.

3. NOTICE TO THE PUBLIC

Accordingly, the Authority at its 331st Authority meeting resolved and the General Public is hereby informed that with effect from the date of publication of this Regulatory Notice in the Uganda Gazette, Licensing of Solar and Wind Power intermittent Power Generation Projects in Uganda shall *inter alia* be governed by the following Policies:-

- 3.1. Invitations and development of new generation capacity from Solar and Wind Power technologies will be subject to a Fair, Open and Competitive process initiated by the Authority in accordance with the Electricity Act, 1999, ('the Act') and Regulations made under the Act.
- 3.2. Development of Solar Photovoltaic and Wind Power Projects shall be subject to the Policy Directives of the Government of Uganda as may be issued from time to time and in accordance with the Act.

The Authority may in the exercise of its functions and discretion in the development of new Generation Capacity from Solar and Wind Technology take into account the following:-

- 3.3. Where the Authority receives a Policy Directive from the Minister of Energy and Mineral Development within the meaning of Sections 15, 16, 17 and 37 (2) of the Act;
- 3.4. Where the Authority determines that the award of a Permit or Licence promotes the development of local content in accordance with the Laws of Uganda as may be in effect from time to time;
- 3.5. Where the development of Solar and Wind Power Projects is in public interest considerations and promotes efficiency and/ or fair competition.

PROVIDED that:

- 3.6. The Applicant complies with Sections 29, 33, and 37 of the Act.
- 3.7. The Uganda Electricity Transmission Company Limited (System Operator) has confirmed adequate evacuation or availability of Private Investment in Transmission and dispatch of the power proposed to be generated from the proposed Solar or Wind Generation facility, in accordance with capacity requirements forecasted for the Electricity Sector Industry and in line with the Least Cost Generation Plan and;
- 3.8. This Policy shall be reviewed by the Authority every Two (2) Years.

This **REGULATORY NOTICE ERA 001/2020** overrides and repeals the applicable provisions of the Regulatory Notice ERA 001/2015 or the Endorsement which are inconsistent with this Amendment. All other existing provisions not referenced in this Amendment remain in effect.
