



The Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 7) Order, 2002.

(Under section 136 of the Traffic and Road Safety Act, 1998).

IN EXERCISE of the powers conferred upon the Minister responsible for works, housing and communications by section 136 of the Traffic and Road Safety Act, 1998, this Order is made this 26th day of July, 2002.

2nd August, 2002

1. This Order may be cited as the Traffic and Road Safety Citation. (Speed of Motor Vehicle) (Exemption) (No. 7) Order, 2002.

Exemption

2. A person who drives a motor vehicle and who competes in a rally competition organised by the Federation of Motor Sports Club of Uganda (FMU) described as DFCU Motor Rally commencing on 9th August, 2002 and ending on 11th August, 2002 is exempted from the provisions of subsections (1) and (2) of section 121 of the Traffic and Road Safety Act, 1998.
