**The Traffic and Road Safety (Speed of Motor Vehicle)  
(Exemption) (No. 4) Order, 2003.**

*(Under section 136 of the Traffic and Road Safety Act, 1998,

IN EXERCISE of the powers conferred upon the Minister responsible for works, housing and communications by section 136 of the Traffic and Road Safety Act, 1998, this Order is made this 15th day of July, 2003.

1. This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 4) Order, 2003.

Citation.

2. A person who drives a motor vehicle and who competes in the four days Rally competition organised by the Federation of Motor Sports Club of Uganda (FMU) and Uganda Motor Club (UMC), commencing on 17th July, 2003 and ending on 20th July, 2003 is exempted from the provisions of subsections (1) and (2) of section 121 of the Act, for the duration of that rally.
